Pursuant to 5 MRSA § 12023, the Maine Port Authority (MPA) is pleased to submit this FY2018 report.

For the period July 1, 2017 to June 30, 2018, the MPA made the following procurements exceeding \$10,000 by sole source because the contractors had a unique feature/compatibility that met the MPA's business needs:

- Tom Bell Media \$14,095
- Woodard and Curran \$75,000

The MPA made the following procurements exceeding \$10,000 for equipment repair and maintenance, which are exempt from competitive procurement under MPA Policy 200-1:

- Central Tire \$11,700 tires for Kalmar reach stacker
- · Kalmar \$15,865 for steering axle repair on reach stacker
- Kalmar \$11,777 for wiring harness, controls for reach stacker
- · Liebherr \$13,804 for tires for crane
- Liebherr \$11,216 for standby technician
- Liebherr \$10,037 for winch inspection
- Reed & Reed \$22,325 for crane/labor
- WD Matthews \$10,649 for radiator repair on Fantuzzi reach stacker
