Pursuant to 5 MRSA § 12023, the Maine Port Authority (MPA) is pleased to submit this FY2019 report.

For the period July 1, 2018 to June 30, 2019, the MPA made the following procurements exceeding \$10,000 by sole source because the contractors had a unique feature/compatibility that met the MPA's business needs:

- Colby Engineering, LLC \$91,817 for geotechnical and design work;
- Eimskip \$572,910 for purchase of on-site chassis and genset pool at the International Marine Terminal; and
- Woodard and Curran For the reason of unique expertise and timeliness, the MPA entered into a contract with Woodard & Curran Constructors for up to \$600,000 in February 2019. The contract was subsequently amended to limit it to up to \$150,000. No funds were expended under this contract during the reporting period

The MPA made the following procurements exceeding \$10,000 for equipment repair and maintenance, which are exempt from competitive procurement under MPA Policy 200-1:

- Phoenix Welding \$11,283 for cutting crane of vessel upon delivery
- Liebherr, USA \$10,371 for crane set up
- Liebherr, USA \$21,052 for crane winch break repair
- Liebherr, USA \$20,853 crane remote joystick purchase and installation
- Eimskip PTI \$127,627 for equipment maintenance

Contributions were made to the following organizations:

- AAPA \$6,745.00 for dues
- Maine International Trade Center \$1,500.00 for trade day
- Eimskip Charity event \$2,500

The MPA made no changes to its financial policies and procedures manual in regard to procurement, contributions or travel during this period. We are working with the Attorney General's Office on a comprehensive review and update all MPA policies, including those related to procurement. We expect to provide you with those updates in the next reporting period.
