Dear President Jackson and Speaker Talbot Ross:

Pursuant to MRSA Title 5, section 12023, the Sunrise County Economic Council (SCEC) is pleased to submit the 2022-2023 Quasi-Independent State Entities Report to the Legislature on behalf of the Washington County Development Authority (WCDA). SCEC is a nonprofit organization that works to create jobs and prosperity in Washington County; we are also the economic development arm of the Washington County government. We provide staff support for the WCDA and are partnering with the Authority in its effort to redevelop the former U.S. Navy base in Cutler.

The former U.S. Navy Base in Cutler is comprised of roughly 20 acres and five commercial buildings comprising 75,000 square feet. The Authority is working to bring these facilities back into productive use. In 2022, the WCDA procured by competitive bid the services of GR Roofing to repair and improve drainage from the warehouse roof. The work was completed in October 2022 at a total cost of \$81,500.00. Findings by Seavee and Mahar Engineering found more hazardous materials than were anticipated through the test. WCDA, EPA and the US Navy are now in discussions over cleanup of the contaminated area.

The Authority made no procurements over \$10,000 for which competitive procurement was waived. WCDA did not make any contributions greater than \$1,000 or changes to policies and procedures in the past year.
