## **Introduction**

Pursuant to 5 M.R.S.A. Section 12023, as a quasi-independent state entity, the Northern New England Passenger Rail Authority is required to prepare and submit an annual report. The section states that:

*“2. Ongoing Reports. By February 1, 2014, and annually thereafter, a governing body shall submit a report to the Legislature containing the following information:*

- A. A list of all procurements exceeding \$10,000 in the preceding year for which competitive procurement was waived under the policies adopted pursuant to section 12022, subsection 3, including procurements exceeding \$10,000 that were made under contracts previously entered into for which competitive procurement was not required. The list must include the names of the vendors and costs associated with those procurements;*
- B. A list of all persons to which the entity made contributions greater than \$1,000 in the preceding year and the total amount contributed to each; and*
- C. A description of changes made in the preceding year to the written policies and procedures required by section 12022 or to the procedures used by the governing body to monitor compliance with those policies and procedures.”*

This report contains the required information to satisfy subsection 2(A), (B), and (C).

## **Background**

The Northern New England Passenger Rail Authority (NNEPRA) is a public transportation authority created in 1995 by the Maine State Legislature to develop and provide passenger rail service for Maine. Our mission is to develop and manage a quality passenger rail system that meets the transportation needs of our customers, delivers value and enhances economic development within the region we serve. NNEPRA manages Amtrak’s Downeaster service as well as providing oversight with other entities to provide station, food service, and marketing support.

Today as a result of a series of investments and improvements, the Downeaster operates five round trips daily between Brunswick, ME and Boston, MA along a 143-mile corridor serving 12 stations in three states with a travel time of three hours and 20 minutes. The Downeaster is an integral part of Maine’s transportation network linking six station communities – Brunswick, Freeport, Portland, Old Orchard Beach, Saco, and Wells - within Maine.

The NNEPRA team is committed to the sustained growth of the Amtrak Downeaster and is exploring innovative ways to improve mobility, advance safety, support a growing economy and provide value for the people of Maine and Northern New England.
