Dear Senator Davis, Representative Martin and Members of the Joint Standing Committee on State and Local Government.

Pursuant to 5 MRS §8056-A, herein is the Secretary of State's report on the progress of the Maine Administrative Procedure Act (APA).

During the year 2017, there were 190 proposed rule filings and 209 adopted rule filings. This represents a decrease of 15 proposed rule filings and a decrease of 23 adopted rule filings from 2016. There are fewer proposals than adoptions primarily because of emergency adoption filings, which do not require the filing of a proposal prior to adoption. There were 14 provisional major substantive rule adoptions submitted by agencies to the Secretary of State and the Legislature during 2017, which is 3 more than 2016. During 2017, 17 new rule chapters were adopted, and 2 were repealed. At the end of 2017 there were 2,076 current rule chapters in effect and on file with the Secretary of State under the APA, 15 more than 2016.

Additionally during 2017, the cost of publishing the Wednesday rule-making proposal notices in five daily newspapers was \$193,918. This was an increase of \$2,081 from 2016. This cost was spread among the rule-making agencies *pro rata*. Pursuant to Chapter 380 of the *Public Laws of 2011*, notice of the adoption of rules is no longer published in the newspapers. Weekly adoption notices are included on the Bureau's (CEC) website along with the rule-making proposal notices.

The Secretary of State solicited comments on the progress of the Maine APA by publishing a notice in five daily newspapers and on the Internet, and by e-mail to state agencies. One comment was received and is attached.

Comments on the MAPA Rulemaking

Don,

I apologize for the lateness of these comments, but I wanted to send them anyway. After meeting with my policy analysts, here are some general suggestions about improving the MAPA rulemaking process:

- 1. In 5 M.R.S. §8053, it currently requires notice to be by mail, with written or electronic submission after the subscriber agrees. We recommend amending the statute to allow notices to interested parties to be electronic, by default. Then such parties may request a hard copy of notices and rule be mailed by the agency.
- 2. Allow for exceptions to the 120-day deadline for adoption, following the comment deadline.
- 3. More detail on hybrid routine/technical and major/substantive rulemaking is needed.
- 4. The MAPA forms are redundant and duplicative. Would it be possible to create a master document that contains all necessary information?
