Source of Report: Title 20-A: Education, Part 5: Post-Secondary Education, Chapter 401: General Provisions, §10011. Retention and graduation rates.

Topic: Reporting of postsecondary data to meet the statutory requirements of MRS, Title 20-A, §10011. Retention and graduation rates.

Context

This report is submitted in accordance with 20-A: Education, Part 5: Post-Secondary Education, Chapter 401: General Provisions, §10011. Retention and graduation rates. Specifically, the statute states that "the department shall report the information compiled under subsection 2, including national comparisons of retention rates and graduation rates for peer institutions, annually to the joint standing committee of the Legislature having jurisdiction over education and cultural affairs...". Subsection 2, previously referenced, is as follows:

Subsection 2: Retention and graduation rates. Using information received annually from a postsecondary institution pursuant to federal law, the department shall annually compile the data to demonstrate:

- A. The retention rates for the previous year for the institution, including the first-to-2nd-year retention rate and the retention rate for first-time students;
- B. For a postsecondary institution that offers an associate degree program or other 2-year program, the graduation rates for students who began their studies within the past 4 years; and
- C. For a postsecondary institution that offers a bachelor's degree or other 4-year degree program, the graduation rates for students who began their studies within the past 6 years.

Focus of the Report

There are varying levels of higher education institutions that operate in the State of Maine; however, not all of these are subject to this report. Only those institutions that fit the parameters of the statute (2-year and 4-year degree program offerings) and are required to report data due to participation in federal financial aid programs are included. *Table 1* lists those institutions.

Data and Definitions

Sources

Most of the data presented are obtained through the US Department of Education's Integrated Postsecondary Education Data System (IPEDS), one of the National Center for Education Statistics' (NCES) surveys. Data from the Carnegie Classification of Institutions of Higher Education (CCIHE), administered by the American Council on Education (ACE), is used to identify "peer institutions." The ACE describes the Carnegie Classification as "the leading framework for recognizing and describing institutional diversity in U.S. higher education" with an "objective, degree-based lens through which researchers can group and study similar institutions." The framework, initially developed in 1970, established norms for defining categories and classifications of postsecondary institutions for multiple variables including academic programs, enrollment, and size and setting. CCIHE uses multiple data sources including IPEDS, the National Science Foundation (NSF), as well as outreach to military service academies.

Cohorts

Federal law requires postsecondary institutions to report completion (graduation) rates for full-time students who complete their program within 150% of the "normal" time of completion. For 4-year programs this would be up to 6 years; for 2-year programs, up to 3 years. For this report, the data for graduation rate follows the Fall 2019 cohort for 2-year programs and the Fall 2016 for 4-year programs. The data reported is for these cohorts unless otherwise noted (for example, the overall national data found in Table 5, is from the Fall 2018 for 2-year and Fall 2015 for 2-year).

Peer Institutions

The Carnegie Classification of Institutions of Higher Education system has been used to identify comparisons for Maine-based institutions. In some instances, a dozen or more institutions had matching characteristics for each of the five fields selected for use.³ To narrow the list of peer comparisons, multiple factors including institution type (public v. private not-for-profit v. private for-profit), regional location (New England or Northeast when possible) and comparable enrollment size were used.

Unfortunately, due to the specificity of certain fields, peer institutions cannot always be identified by using the CCIHE datasets to find exact matches. In some cases, changing one variable (for example 'very high undergraduate' student body composition to 'high graduate') resulted in a potential peer institution. When making modified CCIHE match determinations of this kind, peer institutions were identified based on a greater number of identical categories, similar enrollment, similar public/private status, similar institutional mission, and/or similar geographic setting.

Additional Datasets

The report has also included additional datasets to provide further understanding of the retention and graduation rates. The "full-time/first-time rate" demonstrates how many students attending an institution are "full-time" and "first-time" enrollees. This data helps to provide a better understanding of the population of students that the institution enrolls. For example, those with very high rates of full-time/first-time students tend to have low transfer-in rates. Almost all institutions report this rate.

The inclusion of an institution's transfer rate is another important variable as it helps to illustrate the fluidity of some institutions. Some students attend a particular institution with the intent of gaining competency or a collegiate academic foundation so that they may transfer to an institution that is a better programmatic (major) fit or for other reasons. While that student may be a non-completer, the transfer-out rate indicates that these individuals didn't leave postsecondary participation but left that institution. Not all institutions report this rate.

Limitations

While there are multiple ways to compare institutions, the Carnegie Classification system was used due to the use of categorical structures with multiple variables. Institutions may use this, IPEDS, or even likely competitors for their own comparison purposes related to recruitment, academic performance, or other reasons. The current Carnegie Classification system was released in February 2022 and is, according to ACE, "best viewed as a snapshot of the higher education landscape at that point in time." Classification cycles run for three years, with the next set of data slated for release in early 2025.

Additionally, the statute and the data available do not always line up completely, but the intent is represented. For example, retention and graduation rates are not differentiated in IPEDS, so while an institution may award both 2-year and 4-year degrees, the reported rate generally focuses on the majority of degree completers. As an example, while Maine Maritime Academy offers an associate degree in Small Vessel Operations, the vast majority of graduates are from 4-year programs and as a result the retention and graduation rates indicated in IPEDS are for the 4-year programs. Retention rates are also reported multiple ways by IPEDS. A campus might report a retention rate for both full-time first-time students and part-time first-time students. Only the full-time first-time retention rate is noted in this report.

As previously noted, the Carnegie Classification of Institutions of Higher Education was the primary method used to identify "peer" institutions. Attention was given to selecting institutions with similar location (region) and enrollment. When queries in CCIHE were unable to provide an exact or slightly modified comparison, institutions were selected using IPEDS data to compare multiple variables including type, similar degree offering (associates and/or bachelor), and/or general program focus.

When multiple peer institutions are identified through CCIHE or modified comparisons, two institutions are presented to provide alternative comparisons if graduation and retention rates are reported in IPEDS for that cohort. As Bates, Bowdoin, and Colby are similar institutions, three other institutions with the same characteristics were presented with all six of the institutions being comparable in relation to the CCIHE characteristics. The comparison method column in Table 2 notes whether the peer institution(s) was identified using CCIHE, a modified comparison using CCIHE, or IPEDS data. Table 4 and Table 5 provide the classifications for each institution using the CCIHE taxonomy as well as location-specific and enrollment information.

Retention and Graduation Rates

Table 3 and Table 4 report the retention and graduation rates for Maine and their peer institutions, receptively. For these tables, the following explanations are provided for the IPEDS datasets reported:

- Institution: Name of institution
- Type: Most common degree awarding and institution control
- Retention: Retention rates measure the percentage of first-time students who are seeking degrees who return to the institution to continue their studies the following fall

- First Time: Percentage of 12-month unduplicated headcount who are first-time/full-time students.
- Transfer Rate: Indicates students who left this institution and enrolled at a different institution. Not all institutions report transfer-out rates.

Additionally, it is important to understand that the retention rate which is based upon the percentage of students who began their studies in Fall 2020 and returned in Fall 2021, reported in the tables are dependent on the type of institution (specifically degree-level).

- 1. For a postsecondary institution that offers an associate degree program or other 2-year program, the graduation rates for students who began their studies within the past 4 years
- 2. For a postsecondary institution that offers a bachelor's degree or other 4-year degree program, the graduation rates for students who began their studies within the past 6 year

The graduation rate reported in Table 3 and Table 4 are based on the percentage of full-time, first-time students who graduated or transferred out within 150% of "normal time" to completion of their program.
