**Topic:** Update of Career Readiness Resources for Students

### **Context**

Career readiness coupled with robust economic development will allow Maine to attract and retain a creative and productive workforce. Career readiness is a process that informs individuals about career opportunities, helps them identify their talent, become aware of how their talent transfers into a wide range of occupational opportunities, and enables them to make effective decisions on the academic and post high school pathways that will enable them to pursue their career and life goals.<sup>1</sup> In the 21<sup>st</sup> century, economic development is about investing in people and their communities and in order to grow, communities need to attract and retain talent. Maine is in competition with other states and the world to build and retain a creative and productive workforce.<sup>2</sup>

LD 572, PL 2021 Chapter 75 requires collaboration among the Maine Department of Education (DOE), the Maine Department of Labor Center for Workforce Research and Information (DOL CWRI), and the Maine Department of Economic and Community Development (DECD) to develop age-appropriate guidance and information for students in junior high or middle school and students in high school regarding statewide employment projections, career exploration, extended learning opportunities, internships apprenticeship programs, and career planning.

### **Actions**

#### **Using Statewide Employment Projections to Inform Career Exploration**

**Timeline:** October 2021- June 2022

**Purpose:** Work is underway with representatives from Maine DOL CWRI, Maine DOE, and educators with expertise working with adolescents in middle and high school. The purpose of the collaboration is to create resources to support students' understanding of changing statewide employment projections to inform personal learning, career exploration, career development, and career planning. The work group was established in October and meets every four to six weeks.

## **Applying Statistical Reasoning to Understand Maine Workforce Data**

**Timeline: January-August 2022**

**Purpose:** A team of educators has been tasked with developing a sample middle school unit of study and a sample high school unit of study aligned with the Maine Learning Results Statistical Reasoning Standards and performance indicators. The units of study are designed to support students' development of statistical reasoning skills so they may understand and purposely use the employment trend data to inform their coursework choices, exploration of a variety of post high school options and career plans and their goals.

## **Understanding the Economic Themes Informing Maine Regional Economic Development<sup>3</sup> and Their Relationship to Workforce Development**

**Timeline: January-August 2022**

**Purpose:** In collaboration with educators with expertise teaching adolescents and expertise in economics, develop a middle school unit of study and a high school unit of study aligned with Economics and Personal Finance Standards of the Maine Learning Results. These resources will be designed to support students' understanding of economic development themes and their connection to workforce development so students in each grade span can read the economic landscape and make informed decisions in their career exploration and planning.

## **Extended Learning Opportunities Sample Resources**

**Timeline: October 2020-April 2021**

**Purpose:** Developed in collaboration with Maine educators, Maine Department of Labor Bureaus of Labor Standards, United States Department of Labor, and Maine DOE, these resources were designed to be adaptable samples to support the work-based learning opportunities for students in high school.

## **Summary**

When students understand the relationships in a system (self-knowledge, life skills, problem-solving, aspirations, planning, and career awareness and adaptability) they can make intentional choices that produce desired outcomes. Maine's career resources need to foster transfer of

learning at the conceptual level so students can discover, conceptualize, and organize as they learn to construct and apply knowledge in authentic ways in daily life and the world of work.<sup>4</sup>
