# Board of Visitors University of Maine Annual Report Academic Year – September 2020 to August 2021

#### **Overview**

Chair, Philip Hamilton and Vice Chair, Owen McCarthy and members of the University of Maine Board of Visitors Executive Committee engaged the University of Maine Board of Visitors (BOV) during the 2020-2021 year in substantive discussions regarding initiatives, challenges, concerns and opportunities that impact the University of Maine. The BOV, President and members of the Cabinet met monthly for campus updates.

For 2020-2021, the University of Maine Board of Visitors focused on BOV engagement on issues related to the pandemic and the university's plans for resilience and evolution in a changing world. Themes included the initiatives within UMS TRANSFORMS; Diversity, Equity, and Inclusion; UMaine 2025; R1 Status; and the continued implementation of the University of Maine at Machias as a regional campus of UMaine.

#### **Membership & Officers**

There were 19 voting members of the University of Maine Board of Visitors for the 2020-2021 cycle. The board chairs for the University of Maine Foundation and the University of Maine Alumni Association, as well as a representative for the University of Maine at Machias Board of Visitors served in an ex-officio status. Of the 22 total members, 14 have homes in Maine; the other members reside in California, Connecticut, Florida, New York, Rhode Island, and Washington, D.C., but retain close ties to the state of Maine and the University of Maine. Eighteen members of the total membership are University of Maine alumni. Seven of the voting members are women, as well as two of the three ex-officio members. The members of the University of Maine BOV represent diverse professional backgrounds including but not limited to: architecture, education, engineering, law, finance, healthcare, banking, market development, public service, and nonprofit management. The BOV membership comprises both active career and retired individuals.

For the current year, there are no vacancies on the University of Maine Board of Visitors. New members for 2021-2022: Ambassador Maulian Dana, Mr. Matthew Dunlap, Ms. Barbara Kerr Hamilton, and Mr. Justin P. Labonte.

#### **Schedule**

## UMA Board of Visitors Meeting October 27, 2020 Zoom

**Present:** Dick Thompson, Craig Larrabee, Rebecca Wyke, Joe Szakas, Jon Henry, Buster Neel, Andrew Silsby, Jennifer Riggs, John Finnegan, Joyce Blanchard

**Absent:** Tom Keller, David Cloutier

I. **Welcome & Opening Remarks** – BOV Chair Dick Thompson called the meeting to order at 3:38 p.m. UMA implemented a positive return to campus plan. UMA's Convocation was extraordinarily well-done. Highlighting the rising scholar students was an excellent addition and Dr. Shah gave an exceptional speech.

President Wyke commented on the significant gift by the Alfond Foundation to the University of Maine System over the next ten years. A major portion of the gift is focused on the new Engineering building at UMaine and the new Graduate Center to be located in Portland. The benefit to the smaller campuses, including UMA, is limited to the student success section of the gift. The funds are restricted in their use and do not replace the need to continue our advocacy efforts for financial support from the legislature. Preparation of the next biennial budget is underway.

- II. **Approval of the minutes from the July 28, 2020 BOV Meeting**. Motion made by Andrew Silsby; the motion was seconded by Jennifer Riggs. Motion was unanimously approved.
- III. **BOT/BOV Executive Committee Report** BOV Vice-Chair Craig Larrabee reported that the topics discussed at the meeting were: campus reopening, unified accreditation, budget, and enrollment. Reopening: kudos to each campus; the amount of work has been monumental and focus has remained on student safety. Over 18K COVID-19 tests have taken place. Phase III includes random tests every 7-10 days. Unified Accreditation: the UMS was already deep in to the change process prior to the official model being approved. Multi-campus collaborative programs are continuing to grow; more opportunities for our students. Enrollment: the decline has had an impact, a decrease in in-state undergraduate enrollment has been offset by out-of-state enrollment. There will be slight decrease in our state appropriation as a result of the curtailment. UMS was one of first systems who provided reimbursement to our students. It is not clear if the UMS will receive further federal support. Legislative Update: advocacy and outreach efforts continue. The upcoming summit is scheduled for November 2<sup>nd</sup>. Retiree health plan is a topic of concern for retirees. The communication plan could have been rolled out better. The reaction to the announcement was demonstrated in the number of public comments that were made at the BOT meeting.
- IV. **President's Remarks** – President Wyke reported that the fall safe return plan has been executed well. An advantage of being part of a system, where comprehensive planning and policy creation has been done and this has helped to support the campuses. Through asymptomatic testing we are identifying people who are infected with the virus early. We have done amplified testing in those geographic areas that have experienced outbreaks. We will do a similar regime for the spring term, likely a bit more stepped up. Our initial Emergency Operations Center group transformed to a Safe Return Committee. The focus has been on how to organize our campus to accommodate safe practices. A lot of hard work at the system and campuses have gone in to this, keeping in mind the continuity of operations and best practices for students, faculty, and staff. Students have been very understanding and cooperative with the new class modalities. We have been holding regular open forums to inform the campus since the pandemic began; they have been well received. UMA currently generates approximately 75% of our credit hours on-line; normally we are about 55%. Courses within the cohort programs continue to be offered in-person. The remainder of the student CARES act fund, approximately \$30K, will be sent out to our students soon along with about \$67k in SIP funds under the CARES act and some privately raised funds.

There will be a confirming visit for unified accreditation in the Spring semester; it will be focused on confirming what was written in the substantive change document. The visiting team will also be checking on system-level faculty shared governance. Each faculty senate president is sitting on that group. We will have 1 ½ years to complete the self-study on the standards of accreditation.

The 2025 strategic planning process will be extended into the Spring semester. DEI will be a strong focus. The student welcome center projects were placed on hold in Spring 2020, but we are starting to explore how we might move those forward at a reduced level that fits within the bond funds available and leaves are reserves intact.

- V. Academic Update Joseph Szakas, VP of Academic Affairs & Provost reported that the Board of Trustees has approved two new majors for UMA, a BS in Elementary Education and a BS in Secondary Education. The external accreditation visit for our Mental Health & Human Services program went very well, it is the largest academic program at UMA. The visiting team indicated there were no suggestions for improvement. They also we should explore a master's degree in MHHS. If successful, the UMA MHHS program will be the only accredited program in MHHS in Maine. This is also our first semester offering graduate programs (MS in Cybersecurity, a graduate certificate in Substance Use Disorders). We are also working on a graduate degree in Trauma and Emergency Management. UMA and UMF have reached agreement on a nursing partnership; this is a critical degree tied to workforce needs where student would live at UMF but would be in the UMA BS in Nursing.
- VI. **Enrollment Update** Jonathan Henry, VP of Enrollment Management & Marketing, reported that we experienced a slight downturn in enrollment. On average, we had more students taking more credits. Early college, out-of-state, and graduate enrollments had a very positive impact on our numbers. The loss was cushioned by the mix of our credits for out-of-state and graduate students.
- VII. **Budget Update** Buster Neel, Chief Business Officer reported on the updated FY21 budget for approval by the Board of Trustees (see budget presentation attached). UMA enrollment is down slightly and we have fewer students in housing due to social distancing and the need to retain open rooms for isolating students that test positive. UMA reduced expenses to help keep the budget in balance and also utilized some of the contingency funds. President Wyke, who serves on the Governor's Economic Recovery Committee, noted the ERC is recommending \$75mm to support workforce development and higher education; there is uncertainty around any additional federal funding at this time.

### UMA Board of Visitors Meeting January 26, 2021 Zoom

- I. Welcome & Opening Remarks BOV Chair Dick Thompson opened the meeting and commented that he was interested to hear how UMA's plans unfolded for the fall term in response to the pandemic.
- II. **Approval of the minutes from the October 27, 2020 BOV Meeting** A motion was made to accept the minutes by Andrew Silsby. Jennifer Riggs seconded the motion. No discussion or suggestions for edits were made. The motion was unanimously approved.
- III. **BOT/BOV Executive Committee Report** BOV Vice-Chair Craig Larrabee reported highlights from the most recent UMS BOT/BOV meeting including: Chancellor's Spring semester update, noting that COVID-19 screening protocols will be essentially the same as the fall with the focus on athletes and residential students. The budget update focused on the Governor's budget and Sam Warren provided a legislative update on the federal relief package.

President Wyke provided some additional detail on the budget, reporting that the UMS fared well in the Governor's budget with proposed funding at the pre-curtailment level. Additionally, the Governor included language that would increase the cap on UMS revenue bonding. She noted the supplemental budget for the current fiscal year also provides additional funding for Early College.

IV. **President's Remarks** – President Wyke reported that safe return planning for the return to campus includes testing (out-of-state and residence hall students, athletes, and cohort programs – such as dental & nursing students with clinicals). Starting February 6<sup>th</sup>, all individuals regularly coming to a campus or center will be asked to participate in weekly testing. This asymptomatic testing has allowed UMA to quickly identify and isolate students, faculty, and staff who test positive in order to keep our campuses and centers safe. Mask wearing, hand washing, & social distancing protocols remain in place. Thank you to Jennifer Riggs and Maine General for being an excellent partner to UMA and assisting with getting our student and staff test administrators vaccinated.

The new 2021-2025 UMA Strategic planning process is underway, after taking a hiatus in the fall. An Open Forum will be held to kick off the process. A draft of the new strategic plan with emerging themes and feedback incorporated will be out in March. There will also be another round of survey and roundtable discussions to review the plan and provide feedback. Most notably, work on DEI has come to the forefront in the feedback received, as well as continued support for a number of the initiatives previously included.

The UMA DEI Council is working on a statement of values and mini-grants are available to support programming. Work includes an Equity and Inclusion Scholars program available to undergraduate and graduate students.

A confirming visit on Unified Accreditation will occur this spring and the visiting team will engage with students, faculty, and staff to substantiate the information included in the substantive change document. Another purpose of the visit is assess the progress in developing faculty shared governance at the System level to oversee multi-campus programming. UMS is engaging in a self-study that will span over 18 months. The focus will be to determine how the UMS, under a unified accreditation, will demonstrate that it meets the NECHE accreditation standards.

Federal Higher Education Emergency Relief Funds (HEERF) are on the way -- \$2.9 million in institutional funds and \$675K for students' relief -- we are awaiting guidance from the US DOE the

use of these funds.

Commencements for 2020 and 2021 will be virtual. Communication to students and the UMA community go out tomorrow. The plan is to pre-record everything and run a seamless presentation. The Class of 2021 event will be aired the morning of May 8<sup>th</sup> and the Class of 2020 graduation will be aired in the afternoon. The recordings of each ceremony will be available after May 8<sup>th</sup> for students and families who want to host their own Commencement events with family and friends.

#### V. **Provost Joseph Szakas, VP of Academic Affairs**, reported that:

UMA launched its' first graduate programs – an MS in Cybersecurity and a graduate certificate in Substance Use Disorders. Both programs have attracted more students than originally planned. A third graduate certificate will be offered starting in the fall of 2021 in Trauma Informed Emergency Management.

The UMA/UMaine Foundations program awarded its first "reverse transfer" associates degrees. This innovative partnership allows students who applied to, but were not accepted at UMaine to become UMA students who live and learn on the Orono campus. Once a student successfully completes three semesters with UMA, they may transfer to UMaine. After four semesters, the students "reverse transfer" and receive the associates degree from UMA while continuing to pursue a baccalaureate degree at UMaine.

VI. **Jonathan Henry, VP of Enrollment Management & Marketing,** reported that enrollments are slightly down for FY21. The pandemic presents challenges for our adult students who are struggling to work, raise families and attend college and many are choosing to take some time off from school. UMA's admissions and marketing teams are pursuing several strategies to re-engage these student for Fall 2021. Early college credit hours are up as high schools looked for alternatives for learning this year and out-of-state credit hours are up 12%. UMA is pursuing a conservative enrollment projection for FY22, though we expect growth in graduate programs, the B.S. in nursing due to the fourth year cohort, and prisoner education due to the expansion of the Second Chance Pell program.

Jon noted the Welcome Center Projects are starting up again, but at a smaller scope. The focus is to re-engineering current space versus building new.

VII. **Buster Neel, Chief Business Officer**, reported that we have cautious optimism about ending the current fiscal year in the black. The federal relief funds helped to offset losses that were inevitable due to the pandemic. FY 22 budget planning is well underway with more details to be shared at the next BOV meeting in April.

#### VIII. Other Business

The Andrew Mellon Foundation has awarded UMA \$941K over 2-years to support our prisoner education program with technology, curricula and a director of prison education.

- I. **Welcome & Opening Remarks** BOV Chair Dick Thompson provided a welcome to the members and commended UMA on its strategic planning process. BOV members were grateful for the opportunity to provide feedback and weigh in on the plan.
- II. Approval of the minutes from the January 26, 2021 BOV Meeting A motion was made to accept the minutes by Andrew Silsby. David Cloutier seconded the motion. No discussion or suggestions for edits were made. The motion was unanimously approved.
- III. **BOT/BOV Executive Committee Report** BOV Vice-Chair Craig Larrabee reported on highlights from the most recent UMS BOT/BOV meeting including: Chancellor's updates, noting that COVID-19 screening protocols will be essentially the same through the summer months, with a focus on a safe return to campus plan can be outlined and implemented by early August, 2021.

Craig also shared that on March  $9^{th}$ , four new Trustees were confirmed to the Board of Trustees. On October  $24^{th}$  a special meeting related to USM's new construction was held and was approved.

IV. **President's Remarks** – President Wyke remarked that John Finnegan will be greatly missed. His contributions to UMA have been enormous. Donations in John's honor to the Francis and Mary Finnegan Scholarship Fund have been significant.

UMA Strategic Plan – the survey will remain open until mid-April; then feedback will be incorporated and the plan finalized with the goal of gaining BOT approval in fall 2021. Sections 1-4 are focused on student success, advancing academics, marketing & recruitment, and resources & reputation. Section 5 is on fostering inclusion and outlines UMA's DEI plans.

As a reminder, commencement events for both 2020 and 2021 will be virtual. Students will be invited to create their own individual celebration pages that can be shared on various social media platforms. UMA will present honorary degrees to Travis Mills (2020) and Christopher Cassidy (2021). Captain Cassidy is a retired navy seal and astronaut; two strong connections with our veteran and aviation students. The plan is to pre-record everything and run a seamless presentation. Both commencements (2020 & 2021) will be aired on Saturday, May 8<sup>th</sup>. The recordings of each ceremony will be available after May 8<sup>th</sup> for students and families who want to host their own Commencement events with family and friends.

V. **Provost Joseph Szakas, VP of Academic Affairs**, reported that the AS in Applied Science provides a credential of value half way towards the bachelor's degree, which can be motivating for students.

UMA's Strategic Plan includes a strong student services and retention focus that includes onboarding/advising sessions that will run 60-90 minutes in duration. Research supports that a strong onboarding experience correlates to a successful first semester.

DEI efforts are well underway and DEI case studies are being woven into our curriculum. Additionally, the Justice Studies program is developing a program focused on Penobscot Nations Tribal Law.

VI. **Jon Henry, VP of Enrollment Management & Marketing**, reported that UMA has been very successful in creating a process through which we have awarded three rounds of HERRF federal dollars to our students. We have also focused on awarding dollars to support technology enhancements/increased access.

The Student Lounge in the Randall Center is nearly complete.

VII. **Buster Neel, Chief Business Officer**, provided an overview of FY22 budget. UMA is optimistic about ending the current fiscal year in the black. The federal relief funds helped to offset losses that were inevitable due to the pandemic.

VIII. Other Business – None.

- IV. BOT/BOV Executive Committee Report BOV Vice-Chair Craig Larrabee reported on highlights from the most recent UMS BOT/BOV Summit on June 7<sup>th</sup> held virtually. Craig has requested to share the Databook with the rest of the BOVs, Renee & President Wyke will distribute electronically soon. The majority of this summit was spent on reports.

Tom Keller mentioned that, at least via the virtual format, this summit did not allow for interactions or opportunities to provide input/feedback. A suggestion was made for Craig Larrabee to bring up the idea of building in opportunities for engagement into future summits. Craig and Tom will collaborate on a draft message to send to the BOT/BOV Executive Committee.

President Wyke will also reach out to Kim Marie Jenkins to offer suggestions for building in opportunities for engagement during the next Summit.

V. **President's Remarks** - President Wyke thanked the Board of Visitors for their guidance, advice, and advocacy with the UMS Board of Trustees and the community.

The Chancellor's Listening Tour started today with the UMA Community Town Hall, held in person and via webinar. Chancellor Malloy and Vice Chancellor Thelen met virtually with Faculty members next, followed by the President's Cabinet and then the BOV. The Chancellor and Vice Chancellor will meet with UMA's Vice Presidents on Monday, August 2<sup>nd</sup>, due to vacations this week. The Chancellor will announce an interim President soon.

UMA is transitioning to as much normalcy as possible in on-site staffing beginning August 9th. Employees and students received an electronic communication from the Chancellor earlier this month and employees had the opportunity to attend an open forum with President Wyke about the Fall Return. Supervisors are in the process of communicating with their direct reports about returning to on-site work as appropriate. There is now greater flexibility built in to the collective bargaining contracts, allowing for up to 2 days per week remote for full time employees.

Employees and students who are vaccinated and have voluntarily reported their vaccination to UMS are no longer required to wear masks indoors, participate in weekly testing, or quarantine if they are considered a close contact to someone diagnosed with COVID-19.

UMA will be conducting arrival testing for all unvaccinated students, and weekly testing thereafter for unvaccinated students and staff with an on-site component in their education/work.

There is a new State law regarding required vaccinations (NOT for COVID-19) including Diphtheria, Tetanus, Measles, Mumps, and Rubella. Students must provide proof of vaccination or immunity or proof of medical exemption from a licensed medical provider. We are awaiting specific rules related to this change, which impacts students matriculated in a program, and who attend on site for at least some of their coursework.

Enrollment is on target for both Summer and Fall, with both up 0.1% from last year. We are in a better position with enrollment than our sister institutions. Our adult enrollment is up - we had lost traction with that demographic through the pandemic. Bridge Year (an early college program) is currently down but expected to come up.

President Wyke noted that the UMA Welcome Back Breakfasts as well as Convocation are all being planned in-person. These dates are on your agenda, and you are invited to attend any or all of these events.

VI. **Budget Update** - UMA's E&G budget for FY21 came in within \$116,000 of a balanced budget, however, overall there is a budget deficit. Buster will be meeting with finance colleagues at UMS to determine the usages for the Higher Education Emergency Relief Fund allocation for UMA. This may be able to be applied to part of the FY21 deficit.

The FY22 budget is now under way, and the FY23 budget planning process will begin in August.

VII. **Other Business** - Discussion on evolving US and Maine CDC recommendations. Federal and state health officials recommended earlier today that people in areas with higher COVID-19 transmission wear masks indoors regardless of vaccination status, a designation that includes York and Piscataquis counties.

Motion to adjourn made by Craig; Jennifer seconded the motion. Meeting adjourned at 4:48 p.m.

Five new members, John Moore, Thomas Dukes, Greg Patterson, Jennifer Bjorn, and Barbara Sergio, joined the Board in September 2020.

#### **Officers**

David Levesque, Esq., from the Law Office of David Levesque, served as Chair.

#### **Schedule**

The Board met four times virtually during the reporting year. Board members were also invited to All-Campus meetings, Strategic Planning interviews, and other events and forums on campus throughout the year.

#### **Meeting Summaries**

#### **September 11, 2020**

Board Administration, 16 members in attendance.

Chair David Levesque welcomed the BOV, introduced the new members, and reviewed recent and upcoming encounters. He also encouraged members to engage in the Strategic Planning process significantly, as BOV involvement is critical.

Updates, Discussions and Activities.

Vice President for Student Affairs and Enrollment Management, Christine Wilson, updated the Board on the UMF's safe return to campus, the impact on enrollment, as well as COVID-19 guidelines and policies for the fall semester.

President Serna introduced Berkeley Research Group (BRG), the consulting firm retained to facilitate UMF's strategic planning process. BRG presented their approach, process, and design to tackle the planning process. UMF is currently in Phase II of a four-phase plan and on track for timely completion of the project slated for December. Phase II involves data collection and community engagement. BRG is actively soliciting feedback through interviews, focus groups, and surveys from all members of the UMF community, including the BOV, community leaders, and friends. A comparative analysis of peer institutions is also underway, along with a thorough review of all previous planning efforts.

President Serna reviewed what has been accomplished with our partners at BRG since the strategic planning kick-off back in mid-August. UMF and BRG have conducted a total of 32 interviews with cabinet members, faculty, staff, students, the Chancellor, University presidents, and trustees. BRG has received more than 100+ emails from folks expressing an interest in focus groups participation. Additionally, UMF has hosted four kick-off presentations and lead two Strategic Planning Steering Committee Meetings. There have been two moderated Strategic Planning Q&A Feedback sessions and two community presentations.

This week UMF and BRG launched surveys for staff, faculty, alumni, and community members. President Serna encourages the BOV to take the time to complete the surveys. BRG and the Steering Committee will begin working on assembling and scheduling focus groups. Chair Levesque expressed interest in being a part of the upcoming focus group and encouraged other BOV members to reach out if they were interested.

#### December 11, 2020

Board Administration. 17 members in attendance.

Chair David Levesque welcomed the BOV and turned the meeting over to President Serna and BRG.

Updates, Discussions and Activities.

President Serna and BRG presented the final draft of the strategic plan to campus and the Board of Visitors. Emerging themes were tested since the September BOV meeting, including the UMF identity, the UMF-UMS relationship, student recruitment, retention and experience, as well as Advancement and financial sustainability.

BRG reviewed the desired outcomes and preliminary core objectives of the plan. Three primary goals were identified: community engagement, student engagement and success, and long-term sustainability and growth. BRG has conducted interviews, surveys, focus groups, artifacts review, and market research and is now at the part of identifying objectives and tactics to support the primary goals. These objectives will be clear and specific and will be focused on results that are observable and measurable. BRG provided examples of these objectives and discussed how the desired outcomes of each goal. The tactics will be tailored to UMF and will be realistic and actionable. UMF's core values were updated, which include advancing equity, cultivating UMF's community, commitment to collaborating, devotion to service, empower to trust, passion to learn and drive to innovate.

President Serna encouraged BOV members to review the UMFs Strategic Planning Website, continue to fill out surveys, and email UMF's planning team with any feedback or questions.

#### March 5, 2021

Board Administration. 15 members in attendance.

Chair David Levesque welcomed the BOV, reviewed the agenda, and summarized recent BOT/BOV Executive Committee calls. Chair Levesque encouraged members to reach out if they have any suggestions for possible BOV members to consider for the fall.

Updates, Discussions and Activities.

President Serna invited Katie O'Donnell from Advancement to talk about a new book fund for students called "Books for Beavers." Members will be contacted in the hope that any donation from the BOV can be used as a matching donation for new funds.

Grant activity has been successful recently. UMF has been awarded a \$300,000 DOJ grant for the Office of Violence Against Women and a \$200,000 DOE grant supporting global classrooms. Additionally, Gina Oswald and Theresa Overall helped secure a National Science Foundation – Stem Education grant for \$96,377 to support students with and without disabilities in STEM education and Pathways. Phillip Francis in Religion secured a major faculty research grant of \$220,000, and Drew Barton worked to secure a \$300,000 research grant to help predict wildfire. Team members are currently working on three major grant applications for the coming year.

Vice President of Student Affairs and Enrollment Management, Christine Wilson, discussed the impact of COVID-19 on enrollments. Admissions facilitated over 400 virtual tours and meetings.

President Serna reviewed slides regarding the UMF Strategic Planning process. The plan outlines a three-year timeline that is a highly action-orientated plan that integrates with the budget process. He reviewed the three goals of the plan and will be presenting to campus on Monday. Part of this plan will be a 4-to-3 credit conversion recommendation. Discussion ensued regarding what a shift would mean for academics, workload, and the opportunities it would allow to shape our alignment with other System campuses.

#### June 4, 2021

Board Administration. 12 members in attendance.

Chair David Levesque welcomed the BOV and reviewed the agenda, recent engagement reports, as well as recent and upcoming encounters.

Updates, Discussions and Activities.

President Serna invited members of Advancement and Alumni to review the success of the "Books for Beavers" campaign. The annual BASSA golf tournament already has 100 people signed up to attend. Advancement provided an update regarding the Ferro College Completion Fund and thanked BOV members for their generous support.

President Serna gave a strategic plan update highlighting the zero-based budgeting approach UMF will use for the FY23 budgeting process. This will allow for resources to support the priorities laid out in the strategic plan. The 4-to-3 credit conversation will require every class to be redesigned, but transfer and early college students will have an easier time coming to UMF. In fact, there has been a new full-time early college director hired. The credit structure change will address faculty workloads, advising, research elements, the schedule grid, program elimination and collaboration, and best practices.

An enrollment update was provided, and the numbers were negatively impacted by COVID-19. There was a gradual decline in enrollments as the year went on. We are holding the same numbers of new students this fall as we had last year. Out-of-state numbers are up, but in-state numbers have declined. Admissions continue to hold many virtual events and are meaningfully engaged. The total headcount looks to be down 7% over last year. Enrollment will be working on a new enrollment plan that aligns with the

strategic plan. Marketing will also be working on a new marketing plan that aligns with the strategic plan, and Financial Aid support will be addressed throughout the process.

Four residential hall proposals have been reviewed at UMF. The strategic plan surveys gave us valuable student feedback on what students are looking for in their residential experience. The recommendations are to build residential halls on our campus with private bathrooms, suites, and common spaces with places to cook. BOV members encourage the administration to consider Maine-based vendors.

Chair Levesque and President Serna lead an open discussion on how UMF and the BOV can work together in the coming months as the Strategic Plan is implemented across campus. The conversation continued with ways UMF can connect with community events and engagement opportunities.

Chair Levesque reviewed upcoming meeting dates and recognized outgoing members, Michael Bell, Lynn Farrin, Stephen Brooks, and Jim Gailey. He thanked them for their dedicated service.







#### **OVERVIEW**

Over the past year, the UMM Board of Visitors once again provided valuable support and advice to President, Joan Ferrini-Mundy and Head of Campus, Daniel Qualls and the campus administration. The BOV members' breadth of professional experience, combined with their depth of knowledge about the Washington County culture and economy and their commitment to UMM and its critical role in the region, proved extremely helpful as the University continued to struggle with enrollment and finances, and addressing the challenges and promises inherent in UMM's partnership with the University of Maine, as well as the work of Unified Accreditation.

BOV members served on various campus committees, such as the Planning and Budget Advisory Committee and *ad hoc* work groups addressing Marketing, Student Retention and Success, and Facilities Use. #### MEETINGS AND AGENDA ITEMS

September 8, 2020

President Joan Ferrini-Mundy talked about the campuses reopening after the COVID pandemic with signage, face masks, etc. and students will be tested widely and periodically. Enrollment has turned the corner for the better. We need a definition for the a Regional Campus. How do we leverage the partnership to help enrollment at UMM? Suspension of UMM's Athletic programs is not permanent. Daniel Qualls gave an update on the Safe Return process to bring departments back to campus. Scott Mulcahy will be our new Director of Facilities since Bob Farris retired. Chris Richards, Enrollment Manager at UMaine, is working very closely with our Admissions Office. Faculty are working hard to align the general education core with UMaine. Jacob van de Sande volunteered to remain Chair and Kyle Winslow volunteered to remain Vice-Chair. Charley Martin-Berry volunteered to be the BoV Liaison with UMaine as a replacement for Charles Rudelitch.

#### November 10. 2020

Tora Johnson, Chair of the Environmental and Biological Sciences Division, gave an overview of the new Environmental Geographic Information Systems program with assistance from Trevor Riggin, a student currently in the program. This program is totally online. Jeff Mills from the UMaine Foundation attended and along with Jo Ellen Scribner discussed how the foundation can help us track our alumni. Random COVID testing will continue throughout the semester. Testing will begin again on January 19<sup>th</sup> and be mandatory for residential students returning or entering for the spring semester. We are planning to go completely remote with our courses after Thanksgiving because of the COVID pandemic.

#### January 12, 2021

Marcus LiBrizzi, Professor of English, and student Sam LaRusse gave an overview of UMM's Creative Arts Program. The program allows students to zero in on Creative Writing or Visual Arts. Kim Jenkins from the Office of Organizational Effectiveness spoke with the members of the BoV to gather information about the work needed as UMM moves forward in the Primary Partnership with UMaine. Feedback is generally positive that UMaine is being helpful from financial aid management to residence life. Daniel Qualls mentioned new hires: Brian Shafer from UMFK will be the new Interim Director of Facilities since Scott Mulcahy abruptly resigned. Kaley Clark has been hired as a new Admissions Counselor. Dyandrea LaBonte is a new Resident Director. A new position with UMaine is Assistant Coordinator of Native American Student Outreach and Development which will provide support for Passamaquoddy students. President Ferrini-Mundy and Daniel Qualls will attend a budget presentation to the Board of Trustees. The budget for 2022 will combine UMM's and UMaine's budgets.

#### March 9, 2021

Bob Wood, Director of Downeast Fisheries Partnership, gave a presentation on the different partnerships involved. Their mission objective is to help restore fisheries, to help guide well managed fisheries and to help revitalize our fisheries economy. Lois-Ann Kuntz, Professor of Psychology, gave a presentation on the Psychology and Community Studies program. The program is offered online and on campus. They have many partnerships and shared visions with other programs along with two international collaborations: Soliya and Crossing Borders. Daniel Qualls mentioned that we are preparing our Commencement plan. There will be a pre-recorded portion and a live portion while following all CDC and UMaine guidelines for social distancing and wearing masks. A parade is planned through town after Commencement. A Regional Partnership Project Task Force will work with integrating UMM into the partnership with UMaine. The Task Force is currently working on the Common Catalog between UMM and UMaine.

#### May 11, 2021

President Ferrini-Mundy mentioned that 3 people graduated from the first Family Futures Downeast cohort. UM/UMM budgets will be fully integrated July 1, 2021. The Regional Campus Task Force will review and implement steps for completion of the UMM Regional Campus to the University of Maine. There are 7 working groups and branding for UMM is a priority. The Interim report is due May 20 and the full report will be available to the President on September 1, 2021. COVID testing will take place twice a week for the summer. Daniel Qualls talked about UMM faculty teaching through the Hutchinson Center for concentrations and Associate Degrees. UMM/UMaine have established a Coastal Year Pathways Program – 1+3 undergraduate program. Lateef O'Connor from UMaine is UMM's Interim Director of Admissions. Cara Cushing, our Assistant Director of Communications, has resigned to continue her Master's in Fine Arts.

#### July 13, 2021

John Volin, Executive Vice President for Academic Affairs and Provost, and Joanne Yestramski, Interim Vice President, Chief Business Officer and Chief of Staff, joined our BoV meeting to represent the President. Jacob van de Sande thanked the 3 BoV members who are terming off and welcomed 3 new BOV members: Nakia Dana, Education Resource Coordinator, Passamaquoddy Tribe; Susan Mingo, President at Washington County Community College; and

Juana Rodriguez-Vazquez, Interim Executive Director-Mano en Mano. Elections were held for Chair and Vice-Chair positions: Kyle Winslow unanimously voted as Chair and Charley Martin-Berry unanimously voted as Vice-Chair. Dwayne Shaw from the Salmon Federation received a very large grant and Kay Kimball was granted Emerita status. UMaine's Business School is collaborating with UMM's Business program. The UMS TRANSFORMS initiative is supported through the generosity of the Harold Alfond Foundation. The Student Success and Retention focus area has been provided \$20 million through the grant for student support initiatives, with a challenge to the UMS to match an additional \$25 million to establish a culture of student success, improving outcomes through connection and engagement. Daniel Qualls informed everyone that the asbestos abatement at the Reynolds Center is almost complete. UMM's Interim Director of Student Life has been filled by David Invergo. The Washington County Sheriff's Office is willing to help with our security issues on campus. Deputies will cover the campus on a part-time basis. Sunrise County Economic Council is in a partnership with Machias Savings Bank to open a new Entrepreneurial Center in Machias. UMM is excited about the prospect of collaborating.

#### **Overview:**

In 2020-2021, Luc Nya served as Chair of the University of Southern Maine's Board of Visitors (BOV), with Jane Eberle as the Vice-Chair. The BOV focused its attention on the following areas: supporting, collaborating and helping USM achieve its goals, especially in the areas of enrollment and retention; consultation on USM's 5 Year Plan; employment and career services; participation in system-wide joint BOT/BOV meetings; reaching out to Maine legislators in support of USM and the University of Maine System's legislative agenda; and providing testimonials on the importance of USM and UMS to Maine's economy and businesses, among other issues.

#### 2020-2021 Membership

The USM Board of Visitors began 2019-2020 with twenty members (including the immediate past president). There was one vacancy during the year due to a resignation for work related reasons. There were nine men and eleven women. Thirteen members reside in the Portland or its surrounding southern Maine communities; five reside in Lewiston/Auburn/Lisbon; one residents in the mid-coast region, and one resides in other areas.

#### Schedule

The USM Board of Visitors met six times in 2020-2021. All six meetings were held remotely over Zoom. The Annual meeting is scheduled in June each year. Board of Visitors member's terms had been extended to include the first meeting of the 2020-2021 BOV calendar due to COVID-19.

#### **Meetings and Agenda Items:**

#### Friday, August 28, 2020

Chair Nya welcomed everyone to the first BOV meeting of the 2020-2021 academic year and allowed new members to introduce themselves. Chair Nya noted Laongadao "Tak" Suppasettawat has informed him of her resignation due to a work related conflict. President Cummings provided a brief update on USM's fall reentry plans as students had been welcomed back in the past 72 hours and were still quarantining. The student experience was discussed including how meals are served and activities available while quarantining. A brief budget and enrollment update confirmed optimism with spring retention numbers following past trends and strong Graduate and out-of-state enrollment. Discussion surrounded the role the pandemic was playing on enrollment. President Cummings transitioned and introduced the draft of USM's Five year Plan, outlining 5 key priorities for discussion and feedback. BOV members provided helpful and necessary contributions that the Cabinet will take under advisement as they work to refine the plan throughout the year. Vice President of Human Resources Natalie Jones announced Dr. Idella Glenn will be joining USM as the first Associate Vice President for Equity, Inclusion, and Social Justice. In closing the Foundation previewed the Great University Campaign. 15/20 Members attended.

#### Friday, October 30, 2020

The October BOV meeting opened with Chair Nya discussing the BOV's role on the USM Foundation Board, updates from the Foundation structurally, and informing members that the Foundation would like to meet with each member to consider supporting the Great University Campaign. An update from the President followed, focusing on items relating to Enrollment, Finances, and USM/UMS COVID-19 testing schedule. Focus then shifted to USM's work relating to Race, Equity, and Inclusion. Associate Vice President for Equity, Inclusion, and Community Impact, Idella Glenn, was welcomed and introduced to the BOV where she apprised members of her background, mission, and goals for work. Dr. Glenn introduced the co-chairs of USM's Inclusion, Diversity, Equity Council (IDEC) and IDEC Fellows who briefed the Board. Will Johnson, Director of Intercultural Student Engagement, and Rebecca Nisetich, Director or Honors Program, also informed the board on additional work being done at USM. Questions and in-depth discussion progressed, making sure student voices are heard and promoted while doing REI work. The October meeting concluded with an update from the USM Foundation overviewing the newly launched Great University Campaign. 11/20 Members attended.

#### Friday, December 11, 2020

President Cummings began the December BOV meeting by updating members on the process USM is undertaking to keep the campus and community safe during the pandemic, finances, enrollment, LAC, and the Career and Student Success Center & Residence Hall construction project. Members discussed Finances with a shortfall being noted in Auxiliary revenue, asking for an update on the Roux Institute, and USM's role in the Lewiston-Auburn community. Chair Nya then shifted the conversation to discuss how members envision the Board being run based on an article shared prior to the meeting, *Shaping University Boards for the 21st Century*. Discussion included deepening connections with Faculty, Students, and Staff and how administrative action that can help inform the Board. 14/20 Members attended.

#### Monday, February 8, 2021

The February meeting, the Board was joined by Chancellor Malloy who updated members on the System's testing efforts, Unified Accreditation, and the recent gift from the Alfond Foundation. The Board would like to invite the Chancellor back to continue discussions. USM's Foundation provided an update on their campaign, with the Chair of the Foundation's Board, Dan Crewe providing a moving charge on the importance of the University and campaign. President Cummings followed with an update on the Roux Institute, development project, finances, enrollment, and testing. Vice President for Enrollment Management & Marketing, Jared Cash, and former Vice President for Enrollment, Nancy Griffin, closed the meeting with an in-depth presentation of USM's five year enrollment plan. They focused on the impacts of COVID in admissions, what the current and future landscape of enrollment looks like locally and nationally, and action plans. 10/20 Members attended.

#### Friday, April 2, 2021

April 2<sup>nd</sup> meeting of the BOV began with President Cummings update on the Woodbury construction project, budget, enrollment, and the University's Fall Return and vaccination effort. Representatives from Marketing and Public Affairs presented and discussed the alignment of external marketing and reputational branding with USM's brand and promise. Discussion ranged from shifting to new media and what "winning" may now look like, data metrics to track progress, and external partnerships to strengthen performance. In an effort to get BOV members more involved with the University and deepen their understanding of things happening, presentations were held by the Student Government Association and Academic and Student Affairs leaders to discuss groups, organizations, boards and mentoring opportunities available to members. Many members volunteered as mentors and committed to discussing future roles. 13/20 Members attended.

#### Friday, June 4, 2020

The annual BOV meeting in June began with a welcome from Chair Nya and a discussion surrounding the BOV's bylaws. Chair Nya and President Cummings welcomed interested members to join the Executive Team in discussion of further BOV related items. Rebecca

Conrad's membership was renewed unanimously. Luc Nya was extended unanimously as Chair for another year. Current Vice-Chair, Jane Eberle, expressed to Chair Nya that she would not seek an extension and Rebecca Conrad was nominated and unanimously approved as Vice-Chair for 2021-2022. Potential Memberships were discussed with members noting they would like to review the process and possibilities earlier, while also setting up an ad-hoc nomination committee. Two proposed members, Muhidin Libah and Annie King, were both nominated and approved unanimously. Proposed dates were approved with no objections. President Cummings concluded the year giving an update on record breaking enrollment numbers, diversity and academic standing in the incoming class. President Cummings also noted the impressive Commencement celebration, USM's finalized Five-Year Plan, Finances, DEI Initiatives, results from the "Great Colleges to Work For" survey, and the ongoing construction projects. The USM Foundation thanked everyone for their efforts in support of the Great University Campaign, highlighting Roxane Cole's matching gift on USM's Day of Giving and previewed a large June announcement.

President Cummings thanks all members for their service for the past year and expressed his gratitude for their guidance. In his closing remarks Chair Nya highly recommended BOV Members attend the BOT/BOV summit. 10/20 Members attended.
