This year saw the defeat of the "Industry Bill" for slot machines at commercial tracks and OTB's. At the same time, we saw a successful referendum to have slots at the two commercial tracks. This in turn created a great deal of controversy about the location of a track in Southern Maine. Although this did not effect the commission directly, it did bring an amount of publicity to harness racing.

As 2003 comes to a close, the commission is holding hearings on the viability of a new owner for Bangor Historic Track. This has taken a great deal of the staff's time. They should be commended for keeping things running smoothly under this tremendous load.

I would like to take this opportunity to thank the commission members for their time and effort; you are a pleasure to work with. I would once again thank the staff and Commissioner Spear for their support of harness racing.

The coming year is going to bring many challenges, with racinos, a new gambling board, new legislation and probably new commission members. It is my hope that all can work together for the benefit of harness racing.

First let me thank all those in our sport for making 2003 a very successful year. Unfortunately we experienced a slight drop in our handle in 2003. The amount of the decrease was 2.96% as compared to 2002; yet, the handle for 2003 was still greater than in 2001. Through cooperation by all the tracks we did not experience a horse supply problem that has occurred in the past. Due to revenue shortages we were unable to continue the Pacing Series established with money from the Commission's budget. However, the industry took it upon themselves to create their own abbreviated series with great success. The credit for these Series goes to the Promotional Board and the hosting tracks. I applaud this effort for it exhibited that the industry does work together to better itself using its own dollars.

The Legislature worked with industry groups to draft legislation that would have allowed Commercial Race Tracks and Off Track Betting Facilities to operate Video Lottery Terminals at their licensed facilities. Due to the appearance of the bill being a competing measure with the "Bangor Initiative" the language referencing Commercial Tracks was deleted from the bill. The bill was ultimately withdrawn by the Legal and Veterans Affairs Committee.

The "Bangor Initiative" was approved by the citizens on November 4, 2003. This allows a Licensed Commercial Race Track to operate slot machines provide municipal approval has been granted on or before December 31, 2003. The citizens of Bangor approved operation of slots at Bangor Raceway on June 10, 2004. However, Scarborough Downs did not get the necessary approval by the deadline established in the initiative.

The majority of the staff's time was spent with an ongoing suitability investigation of the new owner of Bangor Historic Track Inc., Capital Seven LLC and Shawn Scott. At the close of 2003 the suitability hearing was still in progress. Since that time Mr. Scott has sold his interest in Bangor Historic Track Inc. to Penn National Gaming requiring another suitability investigation.

I would like to thank Governor Baldacci, Commissioner Spear, the Commissioners, my staff, and all those in our industry for the support, patience and participation in our great sport. Let's move forward with our plans and realize our dreams while not forgetting those who labored before us.

I look forward to working with and for Governor Baldacci, Commissioner Spear and all those associated with our great industry.

### **DUTIES OF THE COMMISSION**

The Maine Harness Racing Commission was created by the Maine legislature to exercise and maintain a proper control over harness racing in Maine for the good of the sport and all persons involved in it and for the good of the state. The Commission's duties include building public trust and maintaining a high level of integrity in all aspects of harness racing.

The Commission is empowered by the State of Maine to establish and enforce rules of conduct for harness horse races, race tracks, wagering and off-track betting. The Commission is required by law to protect the health, safety and welfare of all race participants, of standardbred horses, of spectators and the wagering public.

The work is the basis for the betterment and promotion of harness racing in Maine and for the continued development of Maine's standardbred horses program.

The Commission derives its statutory authority from Maine's harness Racing Laws, contained in Title 8, Chapter 11 of the Maine Revised Statutes. The Commission's principal responsibilities include oversight of harness racing, simulcast racing and off-track betting and support of the Maine standardbred horse program.

To accomplish these responsibilities, the Commission has licensing, enforcement and supervisory authority and the duty to establish rules of conduct for the holding, conducting and operating of race tracks on which any such race or meet is held and for the conduct on the race track of all persons participating in harness horse racing [8 MRSA & 268 and 279A].

The Commission may license any person, association or corporation desiring to hold a harness horse race or meet for public exhibition, including the issuance of race dates (with or without pari-mutuel pools); interstate simulcast racing at a licensee's track during any regular meeting; pari-mutuel wagering at an off-track betting facility; and owners, trainers, drivers, grooms and all other persons participating in harness horse racing, including pari-mutuel employees and race officials. [8MRSA & 268, 269, 270, 271, & 279-A].

The Commission has the power and authority to regulate, supervise and check the making of pari-mutuel pools and the distribution therefrom; to investigate the ownership and control of any licensee; to investigate any suspected violations of the law or rules; and to supervise and regulate all medication administered to horses entered to race. [8 MRSA & 279 & 279-B].

The Commission is authorized to establish a schedule of fines and suspensions and to levy fines and suspensions for violations of the harness racing laws or rules. [8 MRSA & 279-B].

The Commission also has the responsibility to encourage and promote the breeding of a strain of Maine standardbred horses and make provision to encourage donations of the same by licensees or others to persons or institutions within the State for breeding purposes. The Commission has the authority to establish fees and maintain a fund, the Sire Stakes Fund, for establishment of a Maine Standardbred horses program. [8 MRSA & 281].

### **The Commission Members**

The Maine Harness Racing Commission consists of five members appointed by the governor to provide broad geographic representation. The appointments are subject to review by the Joint Standing Committee on Agriculture and to confirmation by the Maine State Senate.

One of the Commission's members is appointed as Chair. The members serve three-year terms, but remain in the post until their successors are appointed. One must be affiliated with an agricultural fair. Three members must be persons with a knowledge of harness racing.

Persons appointed to fill any vacancies that occur serve for the remainder of the unexpired term of the vacancy.

Errol Additon of Leeds, Chairman

Mr. Additon has been active in farming all his life. He is a licensed livestock auctioneer as well as being active in local government as a selectman for over a decade. He has moderated many budget hearings and district school board meetings in Leeds and Turner. He graduated from the Leavitt Institute in 1960 and attended the University of Maine at Orono through 1963. His term expires in 2003

### Michael Andrew of Gorham

Mr. Andrew has been active in harness racing for the past 12 years as an owner. He is employed at the University of New Hampshire as the Director of Teacher Education and as a Professor of Education. A 1956 graduate of Gorham High School, he also earned degrees from Cornell and graduated from Harvard with a doctorate in 1969. His term will expire in 2003.

### Goodwin Gilman of Newport

Mr. Gilman graduated from Dartmouth College in 1959. He has been active in harness racing as an owner and spectator for over 40 years. He is a division manager for Consolidated Distributors and the former owner of Gilman Electrical Supply, Inc. His term will expire in 2004.

#### James Tracey of Farmingdale

Mr. Tracey graduated from Gardiner High School in 1955. He has worked in the banking industry for over 36 years. He has been the Treasurer of Windsor Fair for 15 years and has been instrumental in the development of Windsor Fair serving in a variety of capacities over the past 35 years. His term will expire in 2003.

### Norman Trask of Presque Isle

Mr. Trask graduated from Maranacook Community School in 1981 and from the University of Maine, Presque Isle in 1985. In 1988, he graduated from the University of Maine Law School in Portland. Mr. Trask has a law practice in Presque Isle and has been active in harness racing for the past decade. His term will expire in 2003.

### **MEETINGS OF THE COMMISSION**

The Commission is required by statute to meet at least monthly. Three of the five members of the Commission constitute a quorum to do business. A record is kept of all proceedings of the Commission.

A majority of the Commission meetings involve hearings on violations of the medication or banned substances, rules and hearings of appeals from judges' decisions regarding racing violations. The Chair of the Commission, acting as a sole hearing authority, conducts hearings on minor violations of the rules. The remainder of the Commission's meetings are used for rule-making activities and for licensing issues.

Although only twelve monthly meetings are required by statute, the Commission has found it necessary to hold several meetings each month in order to meet the expanding work load. Increasingly complex adjudicatory hearings, licensing hearings, both for live racing and for off-track betting facilities, and rule-making have created a demanding work schedule for the Commission. The Commission met a total of 14 times during calendar year 2003.

The majority of the Commission meetings are held in Augusta, either at the State Office Building or at another location by announcement.Occasionally, the Commission will meet in Scarborough or in Bangor to facilitate attendance of people from those areas who might otherwise not be able to attend Commission meetings. A published agenda of all Commission meetings is available 10 days prior to each meeting. You may obtain a copy by contacting the Commission office in Augusta or by requesting to be placed on the agenda mailing list.

### **Commission Offices**

The Commission is required by statute to maintain an office in Augusta. During the time in which racing is conducted in the state, the Commission is authorized to maintain branch offices throughout the state.

### Rulemaking

The Commission is authorized by statute to promulgate the rules necessary to carry out and enforce Maine's harness racing laws. In addition it has authority to establish rules of practice governing the conduct of adjudicatory proceedings, licensing proceedings and the rendering of advisory rulings. Agency rule-making is governed by the Maine Administrative Procedures Act found in Title 5, Chapter 375 of the Maine Revised Statutes. The text of that Act is reproduced in Appendix B of the Maine Harness Racing Commission rule book.

Maine law requires that the Commission "provide a booklet containing harness racing laws and rules and relevant portions of the Maine Administrative Procedure Act to every initial licensee and a fee not to exceed \$10.00 must be included in the license fee to cover the cost of this publication.The Commission shall provide necessary revisions of this booklet to those persons renewing licenses at the time of renewal and shall include the cost of revisions, not to exceed \$10.00, in the renewal fee."

In 1993, the Commission completed a recodification of the rules. During 1994, the Commission has worked diligently on a significant revision of those rules, further updating the rules and refining the language for clarity and consistency. A major focus of the 1997 effort has been to update the rules concerning the medications and banned substances contained in Chapter 11. Rulemaking continued through 1999, and a new rule book was issued in 2000. Rulemaking is an ongoing process for the Commission.

The Commission acknowledges the support and contribution of many members of the harness racing community and offers heart-felt thanks for their assistance.

### **GRANTING LICENSES AND AWARDING RACE DATES**

The Commission is authorized to issue annual licenses to any person, association or corporation desiring to hold a harness horse race or meet for public exhibition, including the issuance of race dates pari-mutuel pools; interstate simulcast racing at a licensee's race track during any regular meeting; pari-mutuel wagering at an off-track betting facility; and owners, trainers, drivers, grooms and all other persons participating in harness horse racing, including pari-mutuel employees and race officials.

### **Medication/Testing Program**

### 1. Urine and Blood Program

Test samples were analyzed by the State of Maine Health & Environmental Testing Laboratory located in Augusta, Maine. In some cases the State Lab did use the Maryland Public Health Laboratory, Cornell University Laboratory and the American Medical Association Laboratory to supplement testing of urine samples and/or to accommodate split samples requests by licensees.

Each blood and urine sample received by the laboratory is screened by specialized tests to comply with the ARCI-QAPguidelines for drug detection. These tests include specific extraction procedures, Thin Layer Chromatography (TLC), and Enzyme-Linked Immunosorbent Assays (ELISA).

If screening tests indicate the presence of a drug or unknown foreign substance in a sample, additional specialized testing is performed on that individual sample to prove or disprove the initial findings. All findings are unequivocally confirmed by the use of such techniques as Gas Chromatography, Mass Spectrometry as well as High Pressure Liquid Chromatography (HPLC).

Maine allows the use of phenylbutazone (bute) and furosemide (lasix) in horses under direction of the Controlled Medication Program. The laboratory monitors these two drugs in all equine samples received.

During the 2003 racing year, 2,080 equine urine samples and 795 blood samples were taken. Of the total 2,875 tests taken, 18 were in violation of the medication rules.

Also in the 2003 racing year, 121 human urine samples were taken. Of the total tests taken, 0 samples were found to be positive.

### Violations

### 1.Positive Tests

None in 2003.

### 2. Blood gas Program

The Blood Gas Testing Program was established in 1993 at the request of the Commission. The program requires blood to be taken from the horses at various tracks, refrigerated, and transferred to the Health Environmental Testing laboratory for analysis.

In 2003, the blood gas testing results indicated the following: of the 2,443 horses tested, 2,441 tested within acceptable limits, 2 horse tested positive for violation of a banned substance.

### 3. Controlled Medication Program

The Controlled Medication Program was established in 1992 by statute and allows tolerances for horses who use phenylbutazone and lasix. The program is an on site program and is under the direction of the Commission veterinarian.

The above funds are collected in the Harness Racing Commission office and are deposited in the appropriate accounts in compliance with 8 Maine Revised Statutes Annotated, Section 286.

General Fund monies are used to support the activities of the Commission. The amount of money credited to the General Fund from wagers that exceed \$35 million are transferred to the Commercial Meet Stipend Fund. Seventy-two (72) percent of these funds are distributed to the licensed commercial tracks in proportion to the live wagers placed at their facility to the total wagers placed at all commercial licensees. One-half of the amount received is used to supplement purses and the other one-half is used to reimburse facilities for capital expenditures approved by the Commission. Ten percent is retained in the General Fund; nine percent is transferred to the Sire Stakes Fund; and, nine percent is transferred to the Agricultural Fair Stipend Fund.

Agricultural Fair Stipend Fund monies are distributed to those fairs licensed by the Department in accordance with 7 Maine Revised Statutes Annotated, Section 62.

Extended Meet Stipend Fund monies come from the Agricultural Stipend Fund. Eighty (80) percent of any funds that exceed the \$400,000.00 cap are distributed to those licensed tracks that conduct a race meet not in conjunction with an agricultural fair. The distribution is based on the proportion of a track's live wagers to the total live wagers made at all extended meets.

Fair Stipend Fund monies are generated by depositing five (5) percent of those monies credited to the General Fund. These contributions are used to supplement the premiums paid by agricultural fairs during their annual exhibition.

Sire Stakes Fund monies are used to support purses for the Maine Standardbred Breeders Stakes races, to promote the Sire Stakes Program and to cover any expenses incurred in managing this program.

Promotional Board Fund monies are used to support the activities of the Maine Harness Racing Promotional Board. This organization is an independent instrumentality of the State which hires its own executive director and is responsible for its own budget.

Purse Supplement Fund monies are used to supplement purses at all licensed live racing facilities. The funds are distributed based on the number of days raced by a licensee in proportion to the total number of days raced by all licensees.

Off Track Betting Simulcast Fund monies are distributed to those licensed commercial and agricultural fairs that provide a signal of their races to Maine's licensed off track betting facilities. The funds are distributed based on a licensee's exotic wagers at the off track betting facilities in proportion to the total of all licensees' exotic wagers at the off track betting facilities.

### **OFF TRACK BETTING REPORT**

In 1991 the Maine Legislature enacted legislation that allowed Commercial Tracks licensed by the Maine Harness Racing Commission to apply for and be licensed to operate Off Track Betting Facilities. In 1993 the Maine Legislature amended the statutes to allow Class A Restaurants to apply for and be licensed by the Maine Harness Racing Commission to operate Off Track Betting Facilities. That year there were three applicants that were awarded licenses to operate Off Track Betting Facilities.

Through February, 1996 there were a total of seven successful applicants to operate Off Track Betting Facilities: John Martin's Manor, Waterville,; Spare Time Recreation, Lewiston; Champs Teletheatre, Presque Isle; Miller's Restaurant, Bangor; Jackie's Bar and Grill, Madawaska; Sagtuck, Inc. DBA Winner's OTB, Brunswick; and, Bath House of Pizza and Seafood Restaurant DBA Lower Deck OTB, Bath.

In 2003 there were five (5) OTBs licensed to operate in Maine: John Martin's Manor, Waterville; Spare Time Recreation, Lewiston; Miller's Restaurant, Bangor; Sagtuck Inc. DBA Winner's OTB, Brunswick; and, Main View LLC, DBA Pat's Pizza, Step Two LLC, Sanford.

The total interstate wagering handle recorded by the OTBs in 2003 was \$38,792,112 or a 3.9% decrease from 2002. The total intrastate wagering handle recorded by the OTBs was 1,304,482 or a 8.4% decrease from 2002. The individual wagering information can be found in Part IV, ANNUAL REPORT of the Maine Harness Racing Commission. The revenues to the various Funds from these wagers are as follows:

The Off Track Betting Facilities' share of the total handle is 58.26%. This is a decrease of 2.64% from the OTB share in 2002. This decrease continues the trend set in 2002 and is the result of the continuing increase in inter-track wagering at Scarborough Downs.

### HARNESS RACING PROMOTIONAL BOARD

#### Board origin

The Harness Racing Promotional Board was established in 1993 under Public Law Chapter 388 and later changed in 1997 by Public Law Chapter 528 to promote harness racing activities and increase participation in racing and wagering in the State of Maine. The Board is comprised of nine members and two alternates appointed by the Commissioner of Agriculture. These members represent various components of the industry; terms are staggered for historic retention. Two members represent the Standardbred Breeders; one member serves as a representative from Scarborough Downs and one from Bangor Raceway. The harness horsemen, the agricultural fairs and the off-track betting parlors each have a representative and two members represent the interested public. Two alternates are also appointed on an annual basis, and attendance of these alternates at meetings and other functions has been an added boost for the Board. Board activities in 2003

Early in the year 2003, a change was made in the operation of the Board due to financial constraints and the desire of the Board to follow a slightly different track. The Board had been expending between 20 and 25% of its operational monies for an Executive Director; however, with an ever decreasing amount of funds expected, it decided to proceed with the 2003 year activities with only some assistance from the Department of Agriculture. Board members participated as volunteers on a number of projects.

A budget committee was formed for the first time to project the annual income and expenses expected and to plan for the year. After careful review of the direction that was proposed, a budget was approved and the year ended with many projects accomplished and all bills paid.

Television advertising was the number one choice of the Board as a necessity for the 2003 year. The MSBOA again contributed \$12,000 to this program, and it was a huge success in a year when many changes were presenting additional problems for the harness racing industry in Maine.

Beginning in January, the Board participated in the Northeast Horsemen's Conference and Trade Show at the Augusta Civic Center, followed immediately by a three-day participation in the Maine Agricultural Show. Hundreds of interested people stopped by the booth to discuss current events in the industry and to pick up our annual calendars and pertinent handouts. The booths were staffed each day by Board members and volunteers from MSBOA. For the first time, the Board presented its message and members staffed a booth for the promotion of harness racing at the Maine Association of Agricultural Fairs' annual meeting in Portland. For many fair attendees, this was their introduction to facts and figures concerning the importance of off-track betting parlors to the operation of the fairs and their financial success. Many fair participants did not realize where the annual checks come from that help the fairs succeed.

The annual Legislative Day saw the members of the Board again presenting their promotion of the industry and meeting with members of the Legislature to answer questions and explain positions on bills they were considering in 2003.

Due to budget constraints at the State level, monies for the popular Pine Tree Series were not available. The Board, therefore, put together two small series and furnished purses for the finals. Members were on hand at the fairs and Scarborough Downs to participate in presentations at these races as well as at the finals. Later in the year, a booth was set up and handouts were available at the Portland Mall. Board members again made time to operate the booth.

With plans already underway for 2004, it was decided that a contest would be held to secure photos for the 2004 calendar. These calendars, supported by businesses through advertising space, have become popular items at our booth and in many businesses and town offices.

The Board continues to meet on the second Wednesday of each month at the Farm Bureau Building in Augusta whenever possible. Occasionally, the board will meet at another location; time and/or place changes are noted so that anyone wishing to attend may do so. Meetings are open to the public, and input is welcomed. With pending changed in the industry, the Board hopes for a prosperous and busy agenda in the year to come.

Maine Department of Agriculture, Food and Rural Resources The 2003 Annual Report of the Maine Sire Stakes Program consists of a narrative overview, financial information, purses paid, statistical information of the eligible participants, and final point standings.

For the past few years I have assigned the on site operation of the sire stakes program to Ralph Canney, Program Manager for Live Racing Activities. This has given me more time to devote to the day to day activities of the Commission and administrative functions of staff and the budget. I know it is no easy undertaking to ensure there are no misunderstandings as to the rules and the eligibility of those horses participating. It is no easy task to keep track of the changes in ownership, trainers or partnerships formed after the official lists have been established. Ralph traveled to each racing venue to provide continuity to the drawing of the Sire Stakes races. Again, Ralph did an outstanding job and I thank those who were present to assist him.

I believe the 2003 stakes program was successful. This year was our introduction of splitting the two year old trotters by sex. The numbers did not reflect the enthusiasm for this change but we are seeing an increase the influence of trotters since the Commission adopted the new change. We experienced a decrease in the wagering handle for 2003. It was a slight dip; however, any loss of wagers effects all harness racing programs. The surplus left from the 2002 racing year helped by keeping the base purse even with 2002. Without that surplus there would have been a decrease in the base purse due to the expansion of number of divisions with splitting of the trotters. Again, there will be a surplus carried forward this year. I hope that with this surplus we will be able to lessen the impact due to the splitting both the two and three year old trotters in 2004. Our program continues to be showcased throughout Maine via the four Off Track Betting establishments and Scarborough Downs.

As in years past, the Sire Stakes Advisory Committee recommended to the Commission that entrants to sire stakes events be tested to determine if an alkalinizing agent had been administered. The Committee recommended that up to \$10,000.00 be made available to defray the costs of testing for the alkalinizing agent. The Commission approved the Committee's recommendation.

All the great things accomplished this past year could not have occurred without the support of many individuals and associations. A special thank you goes to each track for hosting and making an effort to promote and provide assistance to showcase our program. Special thanks go to the breeders, owners, Advisory Committee and the MSBOA Board of Directors for all the support and help given us in carrying out our responsibilities.

I look forward to working with all of you in the future and hope we continue to make the program better. On behalf of the Commission and the Department I wish each of you success and good racing in 2004.
