

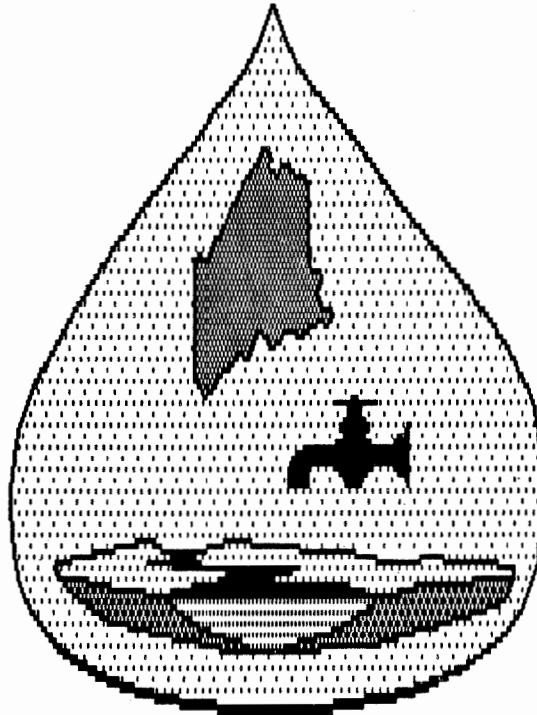

Introduction

This Appendix provides information about public water suppliers in Maine which has been amassed in data base files by the Water Resources Management Board. This information is compiled from several sources, including charter files of the Public Utilities Commission, data base files maintained by the Department of Human Services, Health Engineering Division, and review of Maine Private and Special Laws housed at the Maine Law Library. As a result, the WRMB data base is best reflected by two separate lists: a list of water suppliers which have formal charters; and a list of those which are subject to regulation by DHS under the Safe Drinking Water Act.

The first list in this Appendix is an alphabetical listing of all chartered water districts, with information about the nature of their respective charters. The second list includes all DHS - regulated water suppliers, listed alphabetically by town. The DHS-regulated suppliers printed in bold italics also have legislative charters.

As clarified in the main body of the Legal Framework Report, charters are usually not, of themselves, grants of water rights. Similarly, permits and reports required by DHS are not interpreted as conferring any legal rights to the regulated uses in relation to other legitimate uses of the water resources. Therefore, this Appendix should not be viewed as a catalogue of "publicly-granted water rights" but simply a listing of those entities and uses which have been recognized by the State regulatory and Legislative processes.
