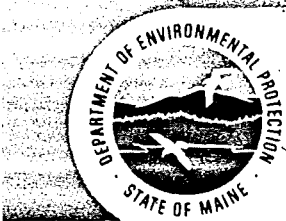

RE: Annual Hazardous Waste Activities Report for 1987

The following report is a summary of the hazardous waste activities within Maine for the calendar year 1987. This fulfills the requirement of 38 M.R.S.A. Chapter 13, Section 1304-A(2). This year's report was derived from using the 1987 annual generator and facility reports. The quantities throughout are reported in tons. The years 1984-1987 are listed below to allow for comparisons.

1987 - 10,749.93 Tons
 1986 - 9,696.70 Tons
 1985 - 9,136.22 Tons
 1984 - 9,121.46 Tons

There was a 1,053.23 ton increase in hazardous waste generated and handled from 1986 to 1987.

This increase in reported waste may be due to a combination of factors, including more reported generators, more complete reporting, and/or more waste generated. During 1987 Department staff conducted a series of educational and informational seminars throughout the State on hazardous waste regulations and management. This effort encouraged generators to notify the DEP and EPA for the first time that they generate hazardous wastes. Also, in distributing the 1987 annual report forms, the Department utilized EPA's complete mailing list of all past notifiers of hazardous waste activity in Maine dating back to 1980. This EPA mailing list included 961 generators, some of which may have been considered "inactive". In the 1986 reporting year, 553 generators received report forms based upon the State's "active" mailing list. Due to this effort to reach a greater number of potential generators, it is difficult to determine if the 1987 figures represent a true increase in the generation of hazardous wastes or if the increase is the result of more accurate and complete reporting.

There was an increase in the number of generators that obtained hazardous waste treatment licenses in 1987. The number of new licenses issued increased from seven in 1986 to twelve in 1987. Most of the new licenses were for beneficial re-use on the site of generation. This indicates that some generators have found it more economical to use recycling equipment to effectively minimize the amount of hazardous waste they generate.

The following includes a characterization of the type and amount of hazardous waste generated and handled in the State of Maine, and the total amount of waste shipped from Maine to out-of-state destinations. The report also includes a list of licensed hazardous waste transporters, licensed hazardous waste facilities that Maine generators use and a listing of consultants and laboratory firms available to Maine generators.
