Chair's Message

The visibility and significance of Maine.gov and its services continues to grow as public demand for digital government increases. In 2017, InforME brought new solutions that streamline business processes and the delivery of information electronically.

On behalf of the InforME Board, I wish to express my thanks to those within state and local government that have made these valuable services and information available online as well as to the citizens and business representatives that continue to utilize these tools.

In 2017, InforME achieved a number of important milestones. Rapid Renewal, the State of Maine's vehicle registration renewal system, welcomed its 225th municipal participant. By the end of 2017, that number increased to 233 municipal participants, meaning that more than three-quarters of vehicles registered in Maine can be renewed using the online service.

Earlier this year, a new agency website template was developed and unveiled by InforME. The template was used to create an updated web presence for the Department of Inland Fisheries and Wildlife (www.maine.gov/ifw). The new website template is available for use by any State of Maine agency and offers several upgrades including user-friendly mobile navigation and multiple options for slideshow presentations.

The first-ever Maine.gov Alexa Skills were developed and submitted to the Amazon store. These skills allow users to play a trivia game and listen to Maine.gov news. InforME plans to grow its Alexa Skills portfolio and launch a winning lottery numbers skill and others in 2018.

InforME continues to expand its service offerings through the deployment of new services and enhancements to existing services. Five website redesign projects were launched including for the Board of Nursing, the Gambling Control Unit, and the InforME web presence. An additional

nine new services were deployed including a septic plan design search, an online code enforcement examination and certification tool, and a product label registration for the Department of Environmental Protection.

InforME also managed a heavy queue of enhancements to existing services and deployed more than 18 significant enhancements in 2017. The online Court Fines service was rewritten and now offers a mobile-friendly interface for the public and streamlined administrative functions for the Judicial Branch. Enhancements to online professional licensing were deployed and an additional three regulatory entities have begun offering this service to licensees. This flexible solution is now offered by 55 unique regulatory entities across three Departments.

In the fall of 2017, InforME Board members, staff from the portal, and staff from OIT/eGovernment Services met to create an updated strategic plan which outlines the vision and direction for InforME over the next two years. The plan focuses on ways in which InforME can increase service usage and participation, as well as ways in which InforME can remain vigilant and focused on a secure portal. We are confident that the successful completion of these goals and objectives will push InforME and the State of Maine to the next level.

Each of InforME's achievements this year, and every year, are a result of engaged Board members, committed state and municipal government partners, and informed constituents. Looking forward to 2018, InforME will continue to provide more interactive and digital government services that enhance the customer experience and broaden the Maine.gov user-base. I look forward to our collective progress as we create innovative solutions that make Maine.gov beneficial to all.

Strategic Plan Update

After nearly two decades as the state's eGovernment portal, InforME has reached a new stage of maturity with more than 160 unique online services allowing users to complete thousands of transaction types online, a consistently award-winning Maine.gov website and a variety of enterprise solutions. This maturity, along with changes to the landscape of the Internet, brings challenges and opportunities. New strategies need to be developed in order to ensure that InforME continues to achieve its vision for serving both state government and the public.

To address these challenges and opportunities, the InforME board held its bi-annual Strategic Planning retreat in September 2017. At the retreat InforME Board members, portal staff and OIT/eGovernment Services staff discussed the key issues facing InforME and strategies to address those issues during the time period covering 2018-2020.

The group agreed that over the next two years, InforME should find ways to:

- Strengthen the message of InforME's benefits to state agencies and the public;
- Identify barriers to online service usage;
- Create user guides and demonstrations to assist users in navigating online services;
- Evaluate emerging technologies and the effect those technologies can have on digital government;
- Evaluate the existing funding and pricing models, service costs, and revise accordingly to remain self-sustaining;
- Create case studies of digital government success stories and present those to government leaders; and,
- Manage complex security concerns.

The four overarching goals below provide the basis for the Strategic Plan. InforME staff and the Board must work together to:

- Continue the long-term financial stability and viability of InforME.
- Provide continued marketing and education to position InforME as the primary resource for online solutions for State and Local government.
- Position InforME to proactively respond to the ever-changing landscape of Internet security threats.
- Promote the benefits of Maine eGovernment services to both citizens and businesses.

Over the next two years, these goals will be achieved through concentrated focus and completion of several objectives and identified strategies. The completion of these goals, objectives and strategies will further position InforME as Maine's premiere eGovernment services provider.

Current and Future eGovernment Services

New and Enhanced Services

ATV & Snowmobile Registration Renewal

The upgraded ATV & Snowmobile Registration Renewal service allows residents and non-residents to register and renew vehicles and roll vehicles over to new owners. Various fees apply based on the vehicle, the registration length and the residency of the registrant. Various Fees. January 2017.

Septic Permit Search

The new service allows the public to search and download any available septic permits maintained by DHHS. Free. February 2017.

Court Fine Payments

The upgraded Court Fines payments service allows users to pay for one or more court fines online. Various fees. February 2017.

Consumer Credit Protection Online Licensing

This service allows licensees overseen by the Bureau of Consumer Credit Protection to renew professional licensure online. Various fees. March 2017.

Absentee Ballot Request

New functionality was added to the absentee ballot request service to allow Uniformed Service and Overseas voters to receive a PDF ballot electronically. Free. April 2017.

Labor Contact Form

A new contact form that connects with the Department's Constituent Management Software allows users to submit questions or comments electronically. Free. April 2017.

City of Lewiston Online Storefront

The City of Lewiston became the first participant to go live with the newest version of the portal's online enterprise storefront service, WebShop. WebShop allows agencies and municipalities to create an official ecommerce presence to sell goods or request donations. The city is currently using the store to solicit donations for upgrades and maintenance to a local park. Various fees. May 2017.

Code Enforcement Exam Application

The service allows current or potential code enforcement officers to take certification exams electronically to obtain their State issued Code Enforcement certificate. Free. June 2017.

Attorney Registration

The Attorney Registration system was enhanced to allow active attorneys to digitally generate their certification "Bar Card" once their registration has been completed and approved. Various Fees. June 2017.

MaineEARNs Data Submission Site

This service allows approved users from State organizations to securely upload data files for archival, research, and reporting purposes, involved the coordination of six unique entities, including Maine's Center for Workforce Research and Information and the Portal. Free. July 2017

Conservation Easement Registry

Enhancements to the conservation easement registry allow a new type of landowner to register and maintain lands online. \$30 per new registration. September 2017.

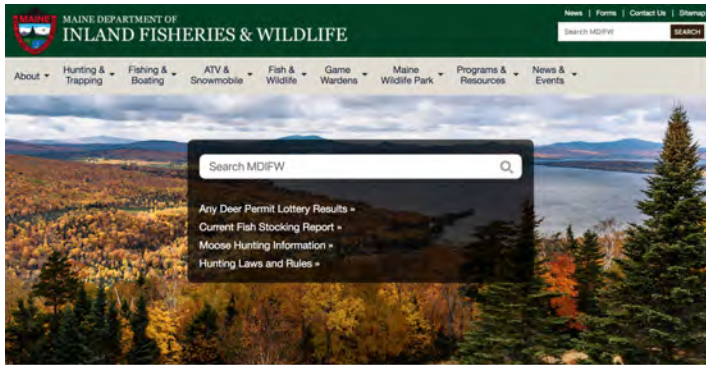
Elver Lottery

The Elver Lottery service allows users to enter for a chance to obtain a Maine Elver fishing license issued by the Department of Marine Resources. \$35 per lottery entry. November 2017.

DEP Bottle Bill Registrations

The online service allows manufacturers, distributors, and retailers to manage the list of registered beverage container labels for transport and sale into the State of Maine. Through the online service, existing container label registrations can be renewed and label registrations can be added. Also, Initiators of Deposit and Contracted Agents can obtain required licenses with this service. Various fees. December 2017.

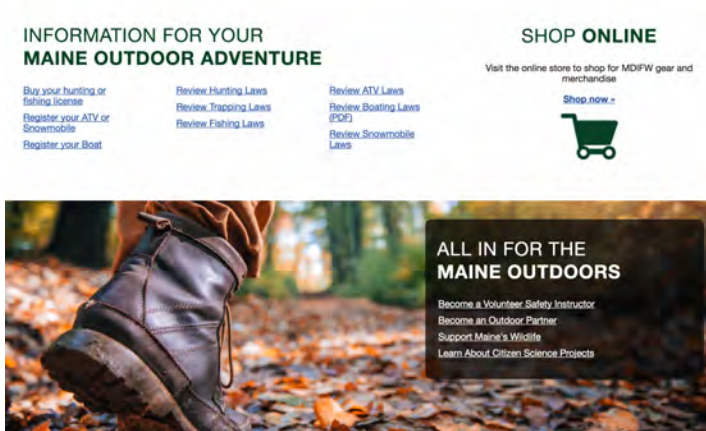

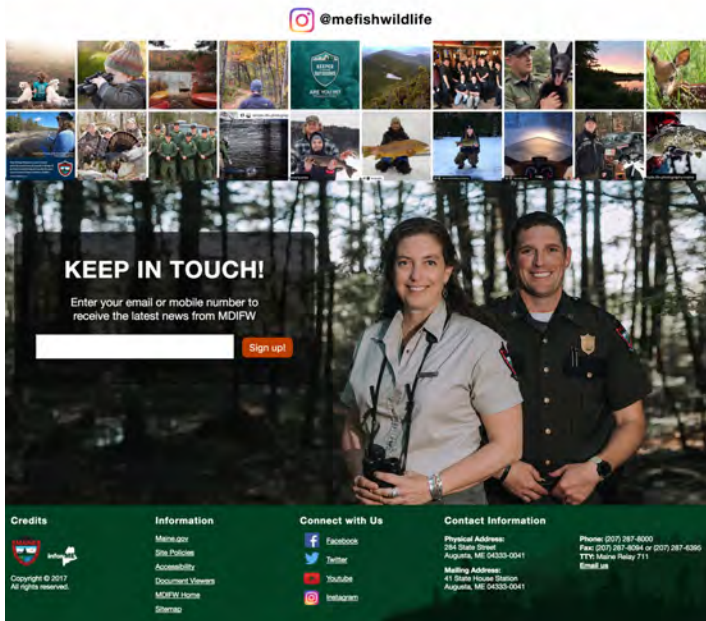

Gambling Control Unit

NEW - See our new Rulemaking Page for proposed Rules**

The State of Maine Gambling Control Unit is a bureau within the Department of Public Safety. This unit provides support to a five member Gambling Control Board appointed by the Governor. The Board is charged with the regulation of casino gaming as authorized by Maine Revised Statutes, Title 8, Chapter 31.

Currently, there are two casino facilities located in the City of Bangor and Town of Oxbow.

An executive director serves as director to both the Gambling Control Unit and the Board. The director provides leadership, oversight, and administration of the three functional areas reporting to the Board. These functional areas include Licensing, Auditing, and Inspections. Each area focuses on a different aspect of regulation within the gaming industry. Specific responsibilities include budget planning, revenue distribution, rule promulgation, policy and staff development, legislative analysis, individual and business licensing, and enforcement of administrative actions.

In 2017, the 128th Maine Legislature assigned the administration and enforcement of the laws governing fantasy sports contests, bingo, and games of chance to the Director of the Gambling Control Unit. A review of these areas is underway to initiate or continue to protect state revenues and maintain the public's confidence in the integrity of gaming activity.

Our mission is to provide efficient, effective, and consistent regulation of authorized gaming in the State of Maine.

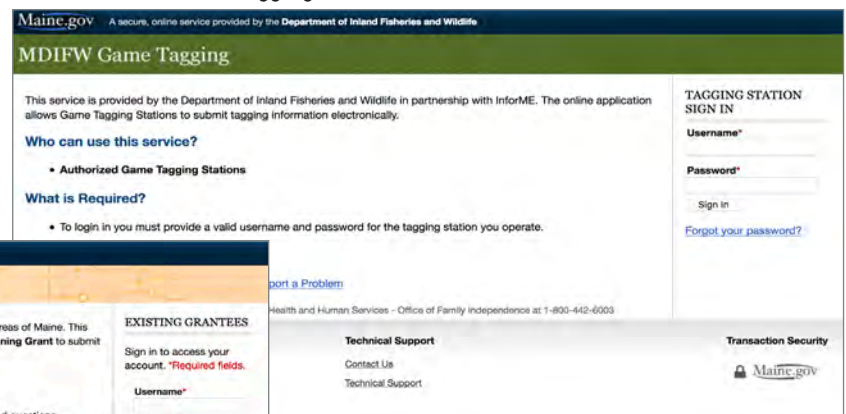

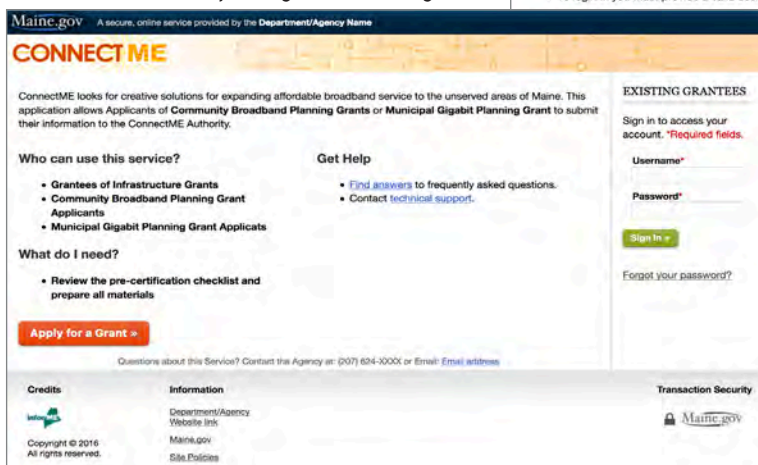

Maine Bureau of Veterans' Services Website Receives Silver Communicator Award of Distinction (May, 2017)

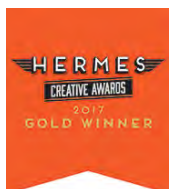
