

SUMMARY: Allows businesses, otherwise required to be closed, to remain open the last four Sundays before Christmas.

COMMITTEE AMENDMENT "A" (S-38): Restricts Sunday openings between Thanksgiving and Christmas to hours between noon and 5 p.m.(ADOPTED)

HOUSE AMENDMENT "A" (H-100): Working on these Sundays could not be made a condition of employment. (Mitchell, E)(Not adopted)

HOUSE AMENDMENT "B" (H-101): Further broadening of Sunday closing law would be subject to referendum. (Jalbert)(Not adopted)

SENATE AMENDMENT "A" (S-60): Working on these Sundays could not be made a condition of employment; and, for employers covered by this exemption, would require time and one-half pay if employee has worked 30 hours in week. (Kany)(Not adopted)

SENATE AMENDMENT "B" (S-62): Same as Senate "A," except extra pay extended to all Sunday workers. (Kany)(Not adopted)
