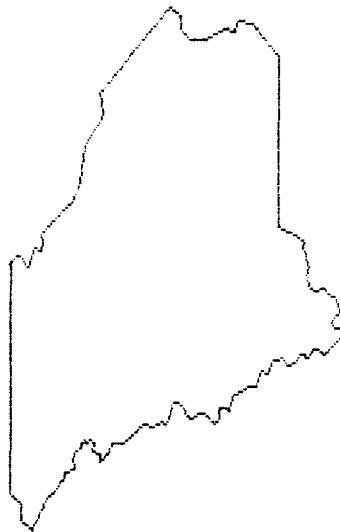

RESOLUTION, PROPOSING AN AMENDMENT TO THE CONSTITUTION OF MAINE TO PROVIDE THAT THE STATE MAY ENACT PROPERTY TAX EXEMPTIONS NOT SUBJECT TO FIFTY PERCENT REIMBURSEMENT Kane OTP-ND-LD1349

SUMMARY: See LD 1349.

880 AN ACT TO CLARIFY THE TAX STATUS OF TIME-SHARING CONDOMINIUMS Twitchell OTP-A ENACT.PL407

SUMMARY: Time share estates separately taxable. Municipal notice fee increased to cover additional municipal costs. Require escrow if managing entity collects taxes from time-share owners.

895 AN ACT TO PROVIDE FOR AN INCOME TAX CREDIT FOR PARENTS WHO PAY PRIVATE SCHOOL TUITION Lewis LV/WD

SUMMARY: Would provide credit for 25% of tuition paid. Maximum credit - \$300 per student. Includes elementary, secondary and higher education.

SUMMARY: Maine Municipal Association bill to increase sales tax to 6%. Additional revenue used to increase municipal revenue sharing and elderly tax and rent refund.
