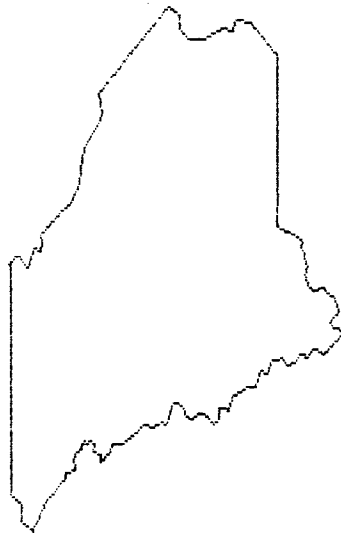

519	AN ACT TO CLARIFY THE DEFINITION OF CHIROPRACTIC	PRAY CHARETTE GWADOSKY HIGGINS, L	(OTPA) PL 1983, c.113

SUMMARY: Redefines chiropractic for purposes of the license law.

COMMITTEE AMENDMENT "A" (S-25): Strikes word "primary" before "provider"; adds word "adjustive"; deletes conflicting language in 32 MRSA sec. 554, which apparently extends scope of practice to whatever is taught in schools. (ADOPTED)

SUMMARY: Specifies a number of specific advertising practices by chiropractors which would constitute violations of the license law; provides a civil penalty for violations.

SUMMARY: Amends the dental licensing law to require identification of removal dental prostheses at time of fabrication or rebasing.

1329	AN ACT RELATING TO THE LICENSING OF DENTAL RADIOGRAPHERS	MANNING BUSTIN GILL CHONKO	(OTPA) PL 1983, c.331

SUMMARY: Provides for licensing of dental radiographers by dentists' board; exempts hygienists, physicians, med students, certain federal employees; requires licensure by September 1, 1984.

COMMITTEE AMENDMENT "A" (H-200): Includes adjacent structures to maxilla and mandible; corrects erroneous references to "on or before" September 1 1984; exempts students studying to be hygienists or assistants, or other licensed radiographers. (ADOPTED)

SENATE AMENDMENT "A" (S-109): Technical correction. (Danton, for committee on Bills in Second Reading.) (ADOPTED)
