SUMMARY: Title explains; extends similar treatment to interstate flights as is now accorded to international flights.

SUMMARY: Sets limits of 5 cents deposit on containers less than one quart; 10 cents on others.

SUMMARY: Would extend coverage of law only to fruit, imitation fruit or tea drinks in 12 ounce metal containers.

HOUSE AMENDMENT "A" (H-292): Includes all types of containers between 7 and 13 ounces.(Zirnkilton)(Not adopted)

HOUSE AMENDMENT "B" (H-192): Includes all containers and extends to liquor and wine bottles. (McGowan)(Not adopted)

SUMMARY: Extends to nonprofit corporations the right to use an assumed name, as is currently allowed to business corporations.
