1907	RESOLVE, ADOPTING A PERMANENT PLAN FOR FEDERAL SURPLUS PROPERTY	Chonko	OTP RESOLVES-1983, C. 49

SUMMARY: LD 1907 is the response of the Department of Finance and Administration to a directive from the General Services Administration (GSA) to establish a state plan by June 30, 1984 for the acquisition, inventory, and distribution of surplus federal property. If a State Plan is not adopted by this date, the state would be ineligible for surplus federal property.

LD 1907 establishes the Surplus Property Agency within the Department of Finance and Administration. The agency will be funded from fees charged to recipients of surplus federal property. These fees are generally 10% of the Fair Market Value of the property but can vary between 3% and 25% of fair market value. Roughly \$96,000 of fair market value surplus property is distributed annually to non-profit health and educational institutions and organizations. The private sector is excluded from eligibility.
