SUMMARY: This bill sought to authorize the Governor to declare a state of emergency when the rated design capacity for prisoners of Maine's correctional facilities was exceeded for 30 consecutive days. Upon this declaration, the overcrowding would have been relieved by a 90 day reduction in the terms of all prisoners incarcerated for nonviolent crimes, sentenced to a term of one year or more, and who were within one year of release.
