SUMMARY: Exempts from cargo insurance requirements logs or pulpwood, garbage, refuse, sludge, junk or unserviceable vehicles, manure, wood chips, bark and hogged fuel.

SUMMARY: Changes some specific amounts from the original bill, establishes a different set of requirements for domestics, corrects some typographical errors in the original bill, and inserts provisions regarding legal services insurance, the subject of LD 2110 (New Draft: LD 2437).

2437 AN ACT RELATIVE TO GROUP (Sewall) (OTP-ND) PL 1983, c. 801 LEGAL INSURANCE ND of 2110

SUMMARY: Makes a number of changes in the original proposal in order to conform this new product to the requirements of the Maine Insurance Code. Defines "health insurance" to include this product for the limited purpose of assuring that multistate life/health insurers who do business in Illinois, Ohio and Texas are not disqualified from operating in those states on the basis that they are writing other kinds of insurance.

HOUSE AMENDMENT "A" (H-689): Seeks to clarify that the superintendent's rulemaking authority shall not conflict with the Supreme Judicial Court's regulatory jurisdiction over attorneys; replaces last section of the new draft to avoid a conflict with enactment of the capital and surplus bill, LD 2137 (New draft, LD 2377, PL 1983, c.709).(Brannigan)(Adopted)

INSURANCE-Other: Not Enacted

2110 AN ACT RELATIVE TO GROUP Sewall ND-2437 H&S-Accepted LEGAL INSURANCE

SUMMARY: Authorizes the sale of group legal insurance by all insurance companies.
