SUMMARY: This resolve sought to authorize the dredging of Meadow Brook by the town of Bingham. The town had sought a permit for the dredging from the Department of Inland Fisheries and Wildlife; permission had been delayed by necessary amendments to the application. By the time the legislation came to public hearing, authorization for some clearing of Meadow Brook had been granted, and the legislation was withdrawn when the authorization was placed in a letter from the department to the town.
