SUMMARY: Provides board and license procedure for occupational therapists and occupational therapy aides and assistats.

SUMMARY: Places the following 7 license boards within the Department of Business, Occupational and Professional Regulation: accountants, architects, barbers, cosmetologists, engineers, land surveyors and Penobscot Bay river pilots.

AN ACT TO ALLOW PERSONS Scarpino LV-WD H&S:Accepted HOLDING OCCUPATIONAL Perkins, A LICENSES IN THE STATE WHO Racine ENTER THE ARMED FORCES TO OBTAIN INACTIVE LICENSES FOR REDUCED FEES.

SUMMARY: Requires that anyone licensed under Title 32 or by any board within the Department of Business, Occupational and Professional Regulation, be issued on request an inactive license for 10% of the active license fee, upon entering the military.
