

SUMMARY: The original draft concentrated on removal of the exemption of immunizing female students of child bearing ages against rubella and adding a specific requirement that immunication for mumps occur in early elementary grades.

The new draft clarifies the education statutes and makes these compatible with chapter 251 on "Communicable Diseases" in Title 22. Specifically, it

- 1. Makes school boards responsible for establishing local policies and superintendents responsible for carrying out those policies and state requirements;
- 2. Clarifies the relevant definitions;
- 3. Clarifies parent's responsibilities to insure their children are immunized;
- 4. Removes the exemption for rubella vacinnation for a female student of child bearing age under the explanation that most females are already vacinated and because of an expansion of the exemption based on physicians statement from condition which would "threaten the student's health" to any condition which is "medically inadvisable;"
- 5. Adds a specification allowing a public health officer to order the exclusion of a child who has not been immunized if the child poses a danger to other children;
- 6. Specifies that the superintendent keep records on immunization;
- 7. Requires the superintendent to provide yearly reports;
- 8. Retains the Departments of Education and Human Services joint rule making authority;
- 9. Retains the authority of local units to establish more stringent requirements; and
- 10. Extends the exemption on confidentiality in 22 MRSA Section 1032 to include school officials so they can have access to records.
