2262 AN ACT TO INCREASE THE NUMBER OF SUPERIOR COURT JUSTICES AND DISTRICT COURT JUDGES

PL 1983, c. 825

SUMMARY: This new draft of LD 1847 provides for one additional Superior Court Justice and one additional District Court Judge.

2265 AN ACT TO CLARIFY THE DEFINITION OF 'TRAFFICK' WITH RESPECT TO GROWING AND CULTIVATING MARIJUANA

PL 1983, c. 775

SUMMARY: This bill amends the definition of drug trafficking in the Maine Criminal Code. Currently, "trafficking" includes growing and cultivating except with respect to marijuana. This bill deletes that exception.

2276 AN ACT RELATING TO THE Joseph ENFORCEMENT AND COLLECTION OF CHILD SUPPORT OBLIGATIONS

PL 1983, c. 782

SUMMARY: As amended by the Committee, this bill permits a Maine State Retirement System member's retirement allowance to be available for satisfaction of child support obligations. The retirement allowance becomes available to satisfy the obligation when the member's accumulated contributions are returnable under statute. The bill also gives the collection of child support obligations priority over the collection of all other debts an individual may incur.

2299 AN ACT TO ENSURE STATEWIDE Joseph UNIFORMITY IN THE PROCEDURES FOR BODY SEARCHES AND BODY CAVITY SEARCHES OF ARRESTEES BY LAW ENFORCEMENT OFFICERS WHILE RESPECTING THE CIVIL RIGHTS AND LIBERTIES OF ARRESTEES
