INSURANCE-Life & Health: Enacted

2453 AN ACT TO ESTABLISH A MAINE (DBOPR Bill) (OTP-ND) PL 1983, c.

SUMMARY: Makes a number of minor changes in the original bill and (1) reduces the maximum assessment from 4% to 2% of the insurer's premiums; (2) seeks to address the single-premium product problem by changing the assessment basis from the impaired insurer's prior year premiums to the present value of the impaired insurer's liabilities on that product; (3) establishes an annuities account separate from the life insurance account; (4) changes several references from an order of liquidation, etc., to a "final order"; and (5) removes the tax exemption for personal property taxes.

INSURANCE-Life & Health: Not Enacted

2333 AN ACT TO ESTABLISH A MAINE (DBOPR Bill) ND-2453 H&S-Accepted LIFE AND HEALTH INSURANCE Brannigan GUARANTY ASSOCIATION Murray Stevens Perkins, A.

SUMMARY: Creates a life and health guaranty association, along the lines of the property-casualty Maine Insurance Guaranty Association, to protect policyholders against insolvencies of those insurers. Does not include coverage of Blue Cross/Blue Shield or variable annuity products.

2441 AN ACT TO CLARIFY THE (Rolde) (OTP-ND H&S-Acc.Min. EXTENSION OF CONSUMERS' ND of 2298 Maj.(12)) Report FREEDOM OF CHOICE REGARDING (Maj. Report) (2442) INSURED MENTAL HEALTH SERVICES

SUMMARY: Identical to minority report (LD 2442, New Draft/Title of LD 2298) except this report makes no requirement of physician involvement in the process of diagnosis of mental illness or emotional disorder by social workers.
