2411 AN ACT TO AMEND CERTAIN
MOTOR VEHICLE LAWS

SUMMARY: In addition to the provisions of LD 1889, LD 2411 proposed the following:

- 1. To provide penalties for various violations of the motor vehicle laws which, prior to the bill, were not specified in the law,
- 2. To require tractors, when operating as any other vehicle except hauling a trailer or semi-trailer, to display 2 registration plates,
- 3. To provide a probationary period for a motor vehicle dealers' license as an alternative to revocation or suspension of the license.
- 4. To provide reciprocity taxes or fees to be levied on non-resident vehicles operating in Maine which are registered in states that levy a tax or fee on Maine vehicles in addition to the taxes or fees levied by the State of Maine,
- 5. To place upon the motor vehicle dealer the responsibility for delivering or providing an application for a certificate of title to the lien holder within a 10 day period,
- 6. To remove the exemption of licensed automobile dealers from the salvage licensing law,
- 7. To exempt bus companies from the provisions requiring freight permits and vehicle identification cards, and
- 8. Removes the date by which pole dollars (utility trailers for "telephone/electric poles) are required to have brakes.
- 2444 AN ACT MAKING ADJUSTED ALLOCA-TIONS FROM THE HIGHWAY FUND FOR THE FISCAL YEARS ENDING JUNE 30, 1984 AND JUNE 30, 1985

NOT ENACTED

SUMMARY: LD 2444, a report of the Minority in new draft of LD 2121 differs from LD 2443 in one provision. This bill established an increase in the stipend to be paid to municipalities for maintenance of eligible roads, but the increase would not be determined until 1985. The increase would take effect on April 1, 1985.
