SUMMARY:

This bill was withdrawn. The boundaries on the bill were not accurate. At the time when the bill had to be finalized the survey was not complete. The bill was written with the surveyor's best estimate. The surveyor was to provide an accurate survey in time for the public hearing but this was not received. A selectman later said that the data in the bill was accurate for the land portion and non-existent for the water portion.

SUMMARY:

This bill is to raise money for renovation and construction of a county courthouse through a self-liquidating bond issue.

The court house project is variously described as follows:

Title - Renovation of and addition to
Preamble - Construction of a county court facility
Referendum - Remodel
Statement of Fact - Remodeled and redesigned

It calls for a bond issue not to exceed \$485,000 to be retired in not more than 20 years. The referendum states that they shall be retired in 16 years.

Committee Amendment A accomplishes the following:

1. Eliminates the confusion as to whether the bill requires a referendum.
2. Adds a provision as to action to be taken if the bonds are not issued or the funds not expended within specified time periods;
3. Changes the referendum question to indicate the amount of interest to be incurred, to indicate the current bond debt status of the county and to change the retirement period to 15 years to match the support data from the county; and
4. Makes a number of minor wording changes.
