SUMMARY:

The original bill provided a definition of "restoration to service" for recipients of a disability allowance. It also divides the existing provisions governing restoration to service into two subsections for purposes of clarification. The Committee Amendment (CA-H-22) transferred the location of the definition to the definition section of the Retirement Statutes.
