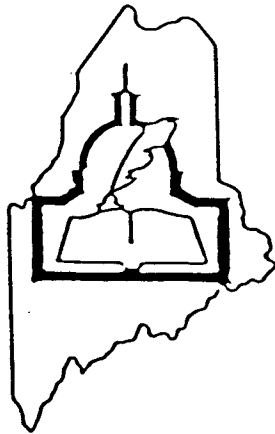

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: Heldover from the First Regular Session of the  
112th Legislature. The bill proposed an amendment to the  
Atlantic States Marine Fisheries Compact. The primary  
purpose of the amendment was to establish independent  
rule-making authority for the Compact. The value of this  
would have been to streamline the administration of  
fisheries conservation measures adopted under Compact  
authority. The amendment further proposed a system of  
cross-deputizing law enforcement personnel among member  
states and the federal government. The majority of the  
committee reported the the bill "ought not to pass" because  
of concern over the independent rule-making authority.
