SUMMARY:

The bill prohibited a financial institution or insurance agent from recommending an attorney to a borrower or imposing additional legal costs in a residential mortgage loan. Under the Committee amendment (S-119), a financial institution or mortgage company must inform a borrower of his right to choose an attorney and the prohibition against additional fees for review of that attorney's work, but if the mortgagor does not exercise that right, the lender may recommend an attorney. Also, disclosure of records required under the Federal Currency and Foreign Transactions Reporting Act is made exempt from the confidentiality requirements of the Maine Banking Code.
