SUMMARY:

This is a bond bill for the court house at Bath. Sagadahoc County currently has no expenditure in 1095 - Debt Service.

Committee Amendment "A" indicates that the bond is for the total courthouse, not just the portion used for court. It adds a section requiring that funds not expended in 10 years shall revert to the debt service account. Finally, it adds a statement concerning debt service which shall accompany the referendum question.

Senate Amendment A was presented on behalf of the Committee on Bills in Second Reading to reinsert portions of the original amendment which were inadvertently omitted.
