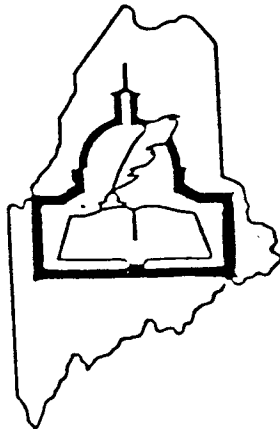

LD: 1077 AN ACT TO AMEND CERTAIN FISH AND GAME LAWS MICHAUD

SUMMARY:

The purposes of this bill are:

1. To provide for the issuance of free hunting and fishing licenses to persons 65 years of age or older and to persons with a military service connected disability; currently free licenses go to those 70 years and older and those with 70% disability; and
2. To establish a muzzle loading hunting season.

SUMMARY:

Currently it is permissible to operate registered snowmobiles on a public way. The purpose of this bill is to prohibit the operation of all ATV's on public ways except when crossing a public way or bridge.

SUMMARY:

The purpose of this bill is to authorize an award system of \$10,000 for 1985-86 for the most and largest coyotes killed in the State.

Committee Amendment A reduces and changes the prize structure of the program. It specifies supersport license fees as the source of funding for the program. It excludes department employees from participation. It provides for a 2-year sunset. It funds the bill for 2 years but does not change the total amount allocated. Instead, it merely extends the funding in the original bill over the 2-year period.
