SUMMARY:

This bill makes several technical changes in the education statutes. It deletes outdated language and clarifies language to reflect current practices. The section proposing to repeal the Teacher Placement Office and transfer the resources of that program to meet the certification needs of the department received considerable discussion.

CA-H-200: The Majority Report would have deleted 2 sections of the bill which are duplicated in LD 190, retained the section repealing the Teacher Placement Office and provided for reallocation of its resources for teacher certification.

CB-H-201: (Adopted) The Minority Report deletes the 2 sections of the bill duplicated in LD 190 and deletes the section of the bill repealing the Teacher Placement Office.

School units are presently required to display the American flag at each school. The bill requires that flags be displayed in every classroom. The new draft changed the location of the new provision from a section dealing with special observances and a subsection dealing with the duties of instructors to teach about the flag to a section dealing with the superintendent's responsibility to make sure the flag is displayed.

SUMMARY:

The bill would have given school boards the authority to "dismiss, refuse to reemploy or suspend any teacher, student teacher or teachers' aide who, in any class during school hours, advocates homosexual activity." The term advocate was defined to include a range of behavior from "advocate, solicit, or impose the approval or acceptance of an activity" to "encourage or promote the approval or acceptance of an activity." Homosexual activity was defined as "any sexual act or sexual contact between persons of the same gender."

At the public hearing one of the co-sponsors of the bill proposed substituting a new draft for the bill. The new draft would have allowed the superintendent and school board to dismiss a teacher for not following the school board's instructions if the teacher did not refrain from teaching certain subject matter when told to refrain by the superintendent.
