SUMMARY:

According to this Act, the voters of Wallagrass Plantation
voted in November, 1984 to incorporate into the Town of
Wallagrass.

This Act seeks to have the results of the vote validated,
confirmed and made effective. It also seeks to have the vote
approved upon certification to the Secretary of State. The
validation, confirmation and effectiveness are to take effect
at the first town meeting.

This new draft eliminates the emergency provisions of the
bill. It adds the standard provisions for changing a
plantation to a town. It specifies the effective date as the
first town meeting in March, 1986.

House Amendment A inserts sections of the original bill that
were inadvertently left out in the new draft.
