SUMMARY:

This bill establishes specific criteria on which municipal officers may rely in granting or denying liquor licenses for on-premise consumption establishments.

SUMMARY:

This bill creates a new class of liquor license: Class A Lounge. The Class A Lounge license has less stringent food volume requirements, but prohibits minors and the fee is over double the Class A restaurant license fee.

SUMMARY:

This bill revises the method of measurement of the 10-mile minimum distance between State and agency liquor stores. It also permits the licensing of seasonal agency stores on a trial basis.
 House Amendment "A" (H-164) (Not adopted) would have retained the current law regarding liquor store spacing.
 Senate Amendment "A" (S-148) exempts the seasonal agency stores from the 10-mile spacing and adds a fiscal note for the resulting increase in State revenues.
