SUMMARY:

Original LD 1216 would have required all occupational and professional licensing boards to have at least 2 public members, replacing professional members if necessary. The majority report, LD 1631, required 2 public members, to be compensated at the rate of \$35/day and required the boards to recommend to the Legislature which professional members should be replaced by public members. House amendment A (H-282) increased the membership on the Auctioneers' and Plumbers' Boards and allowed a delay in public member appointment when the appointing authority wished to reappoint a current professional member. Senate amendment A (S-216) increased the membership on the Auctioneers' and Plumbers' Boards and removed the requirement of a report to the Legislature. Senate amendment B (S-229) made the same changes as Senate amendment A, plus making it clear that no one may be removed from a board to make room for a public member.

The minority report, LD 1632, prohibited any public member from having conflicts of interest and set their compensation at \$35/day.
