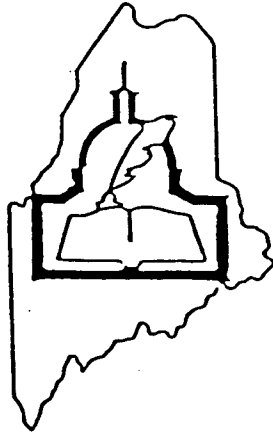

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

AN ACT TO AUTHORIZE THE PORTLAND SCHOOL OF
ART TO CONFER ASSOCIATE DEGREES

H-533 CA H S

SUMMARY: The bill authorizes the Portland School of Art to confer an Associate of Arts degree. The school is presently authorized to grant the degree of Bachelor of Fine Arts.

CA-H-533: The Committee Amendment added an emergency preamble and effective date clause to the bill so that the school may issue associate degrees to eligible students at this Spring's graduation exercises.

AN ACT CONCERNING THE SELECTION OF THE
CHANCELLOR OF THE UNIVERSITY OF MAINE SYSTEM

Committee Report: LVWD

SUMMARY: This bill would have changed the way in which the Chancellor of the University of Maine is appointed and evaluated. The bill would have created a 10 member broadly representative nominating committee to select a nominee for the position of Chancellor. Following nomination by the committee, the nominee would have been subject to legislative confirmation as provided in Title 3, section 151 of the M.R.S.A. The bill also would have provided a process for a formal annual evaluation of the Chancellor by a 7 member committee. Finally, the bill would have established a 5 year, renewable term for the Chancellor.
