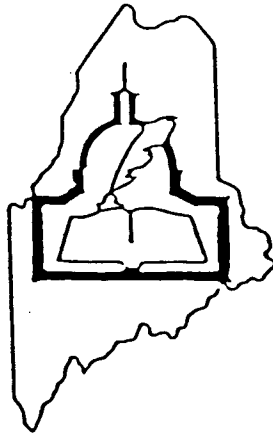

JOINT STANDING COMMITTEE
BILL SUMMARIES
MAY 1986

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

LD AN ACT AUTHORIZING THE DEPARTMENT OF ENVIRONMENTAL PROTECTION TO CONTRACT FOR CERTAIN SERVICES LVWD
1796

Sponsor: MICHAUD, Brown, D.
Committee Report: LVWD

SUMMARY: This bill proposed a procedure whereby the Dept. of Environmental Protection could hire technical consultants for large applications with funds supplied by the applicant. The procedure was contingent upon joint agreement by both the applicant and the DEP. The Committee granted the sponsor a leave to withdraw report.

LD AN ACT CONCERNING STATE CONTRIBUTIONS TO POLLUTION ABATEMENT ND LD 2071
1797

SUMMARY: See New Draft, LD 2071.

LD AN ACT TO GIVE MUNICIPALITIES GREATER DECISION-MAKING POWERS RELATING TO SOLID WASTE MANAGEMENT ONTP
1814

Sponsor: MURPHY, E., Farnum, Handy, Tuttle
Committee Report: ONTP

SUMMARY: This bill would have required any solid or hazardous waste disposal facility which intends or begins to accept waste generated outside the municipality in which it is located to notify the municipal officers of its intent or action. Within 90 days of that notice, the municipality would have been required to hold a referendum on the acceptance of waste from outside the municipality. The results of the vote were to have been sent to the BEP. The Committee felt that sufficient public participation provisions already exist in law and that matters such as this could be better handled through municipal zoning ordinances.

LD AN ACT TO AMEND AND CLARIFY THE STATUTES GOVERNING CONTROL OF HAZARDOUS AIR POLLUTANTS ND LD 2072
1815

LD AN ACT TO REGULATE THE SURFACE DISCHARGE OF LVWD
1857 GROUND WATER WITHDRAWN FOR USE IN HEAT PUMPS

Sponsor: COLES, Usher, Holloway, McGowan
Committee Report: LVWD

SUMMARY: This bill would have prohibited the discharge of ground water used in a heat pump system unless it were returned to the aquifer from which it had been withdrawn. Owners of heat pumps on January 1, 1986 would have had 3 years to comply with the law. During work sessions several alternative approaches were discussed; among them: limiting application of the prohibition to coastal areas, banning open-loop system, and requiring any heat pump system to be of the closed loop type. In the end, there were too many unanswered questions regarding the extent of heat pump use, their environmental impact, the relative merits of closed vs. open-loop system, and the impact of regulating their use. As a result leave was granted to the sponsor to withdraw the bill.

LD AN ACT TO PERMIT STATE REGULATION OF DAM ONTP
1874 IMPOUNDMENT AREAS

Sponsor: DAVIS, Jacques
Committee Report: ONTP

SUMMARY: This bill would have repealed the exemption for certain bodies of water created by dams authorized under the Federal Power Act from the regulatory authority of the BEP to establish a water level regime for those impoundments. Discussion at Committee work sessions indicated that there are 41 exempted dams held by 6 owners and that occasional conflicts do occur between dam owners and landowners. However, it seemed that given the small number of dam owners and the nature of the conflicts, resolution of those conflicts might best be accomplished without legislative action. Accordingly, the DEP was asked to set up a meeting with dam owners to discuss the problem (4 of the 6 dam owners were represented at the work sessions and agreed). The meeting has been expanded to include land owners, lake associations and wildlife groups.
