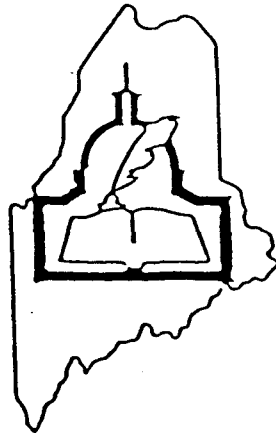

BILL SUMMARIES  
MAY 1986

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

LD 1829 AN ACT TO AMEND THE CHARTER OF THE  
PASSAMAQUODDY WATER DISTRICT

ND LD 2299

Sponsor: VOSE, Brown, L.  
Committee Report: OTP-ND

SUMMARY: The District needs a new water source or it would have to build an expensive treatment plant. The bill would authorize the District to purchase and take water from land now owned by the Lincoln Company, which is outside the District. The bill also authorizes the District to sell or lease surplus property.

LD 1830 AN ACT AUTHORIZING THE PUBLIC UTILITIES  
COMMISSION TO REQUIRE AN ELECTRIC UTILITY TO  
SUBMIT A LONG-RANGE ENERGY PLAN LVWD

Sponsor: MCHENRY, Clark, H., Andrews, Richard  
Committee Report: LVWD

SUMMARY: Existing law (35 §13-C) allows major electric utilities to file a long-range energy plan. That plan would provide the factual basis for regulatory review and could speed up PUC approval of construction of new facilities. However, no utilities have taken advantage of this provision.

The bill allows PUC to order such a plan and authorize a filing fee of \$50,000.

LD 1831 AN ACT TO PROHIBIT MANDATORY LOCAL MEASURED  
SERVICE AND TO PRESERVE TRADITIONAL FLAT-RATE  
TELEPHONE SERVICE AT AS LOW A COST AS POSSIBLE LVWD

Sponsor: REEVES, Martin, J., Dellert, Rydell  
Committee Report: LVWD

SUMMARY: This bill prohibits mandatory local measured telephone service, preserves traditional local telephone service at as low a cost as possible and limits the percent of customers who will be provided optional local measured service.
