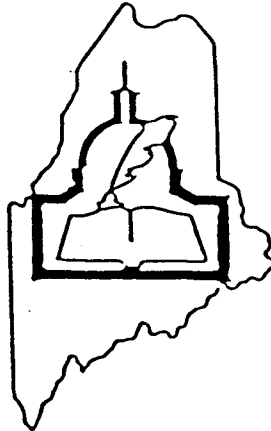

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: This bill allowed the Lucerne-in-Maine Village Corporation to enter into long term contracts for the disposal of the residents' solid waste.

Committee Amendment A required that the proposed referendum take place during the corporation's regular summer meeting.

House Amendment A changed the word removal to the word disposition in the wording of the amendment question.

SUMMARY: L.D. 1891 defined 2 terms employed in the manufactured housing zoning law. It provided technical definitions of "permanent foundation" and "pitched, shingled roof."

LD AN ACT CONCERNING ENFORCEMENT OF VIOLATIONS  
1964 RELATING TO HANDICAPPED PARKING

Committee Report: LVWD

SUMMARY: L.D. 1964 amended the law relating to the enforcement of handicapped parking spaces in private parking areas. It required local law enforcement officers to enforce those handicapped parking restrictions upon written request of the private owner.
