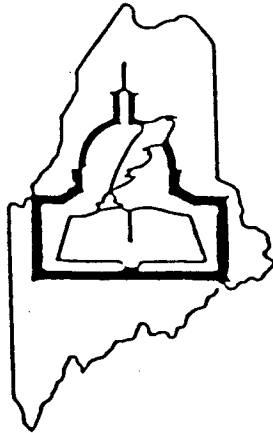

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: Current law requires that all polls, except in municipalities of less than 100, must open no earlier than 6 a.m. and no later than 9 a.m., and must remain open until 8 p.m. The bill allows municipalities of 2,500 or less to delay opening their polls until 10 a.m.

The Committee Amendment extends the delay to municipalities of less than 4,000, to be consistent with the population line for the required number of voting booths.
