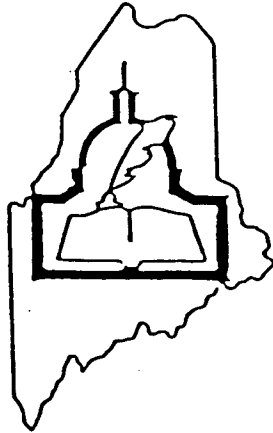

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: This resolve changes the final reporting date of the Joint Select Committee for Learning Disabled Children from January 1, 1986, to January 1, 1987, and provides for an Interim Report in March 1986.

CA-S-382: The Committee Amendment deletes unnecessary language requiring that the Joint Select Committee's interim report include suggested legislation. The amendment also adds a Fiscal Note and an Appropriation of \$2,000.

SA-S-387: The Senate Amendment to the Committee Amendment changes the reporting date for the final report to "prior to the convening of the Legislature in December 1986."

AN ACT TO AMEND THE LAW SEPARATING THE OGUNQUIT
VILLAGE CORPORATION FROM THE TOWN OF WELLS

ONTP

Sponsor: WENTWORTH
Committee Report: ONTP

SUMMARY: The bill would have altered the method by which local costs are apportioned between the two towns in the Wells and Ogunquit CSD. At present the apportionment is on the basis of property valuations. The proposal would have changed the formula to have it based 25% on valuation and 75% on the number of students in each town. The bill would have also added the provision exempting the town of Ogunquit from the cost of retiring bonded indebtedness incurred after July 1, 1980 unless the voters in the town of Ogunquit approved the issuance of those bonds.
