This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: This bill sought to limit the liability of defendant parents who sue for their pain and suffering because their child was abused by an employee of a day care center for children to \$300,000 maximum. The bill provided that insurers would not be liable for damages caused by employees who were hired by the employer without the employer ascertaining the criminal record, if any, of the employee. Under the bill, insurers need not cancel a "home owner" policy when cancelling that part of the policy relating solely to liability for the operation of a day care center for children.

The bill was withdrawn upon discovery that the market assistance plan (MAP) established for day care centers last year by the Bureau of Insurance is succeeding in making liability insurance available to all but a few centers. (A MAP is a pool of insurers who agree to share the provision of insurance to high-risk customers.)
