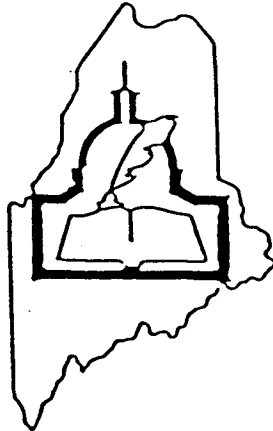

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: LDs 2058 and 2059 requested authorization to proceed with two bond issues without voter approval of the properly worded referendum.

In the general election held November 5, 1985, the voters of Waldo County authorized the county commissioners to issue bonds. The ballots used in the election posed the question that was contained in the original Legislative Document. When the Legislative Document was finally enacted by Private and Special Law 1985, the question to be asked the voters at referendum was worded somewhat differently and a disclosure relating to debt service was required to be placed on the ballots. In preparing the ballots for election, the county official inadvertently prepared them with the question contained in the original Legislative Document.
