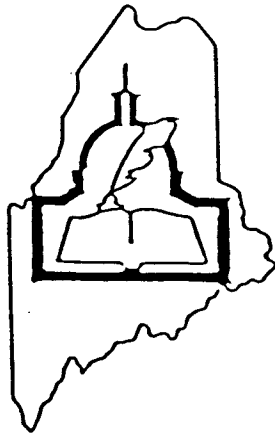

BILL SUMMARIES
MAY 1986

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Regular Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: This resolve reauthorizes the DMR to conclude negotiations with the federal government regarding the leasing of property at the Boothbay Harbor DMR lab to the Bigelow Laboratory, a private, scientific, nonprofit organization. The resolve also extends the leasing authorization to cover properties newly transferred from the federal government to the DMR.

LD AN ACT REGARDING MUSSEL DRAGGING LVWD

SUMMARY: This bill proposed a closed season on mussel dragging, established definitions of "commercial" and "seed" mussels, restricted drag sizes, limited seed mussel harvesting to designated areas in the intertidal zone, and required "on-board" processing of all mussels. The bill and a companion measure (see LD 1904) were granted a leave to withdraw after the sponsors and the committee agreed to request an interim study on the subject.

S-438 CHALMERS H S

SUMMARY: This bill corrected an oversight in the marine license fee increase bill from the First Regular Session of the 112th Legislature (PL 1985, c. 379). The commercial scallop boat license was raised from \$33 to \$53. The bill also created a \$5 recreational scallop diving license. The Committee unanimously approved the bill. A technical amendment (SA-438) corrected certain legal deficiencies in the bill.

H-601 CA H S

SUMMARY: This bill reduced the nonresident commercial fishing license fee from \$900 to \$200. Very few nonresident licenses are currently sold. Concern over the success of the new Portland Fish Display Auction led to this effort to remove barriers to the participation of nonresident fishermen in the Portland Auction. The Committee unanimously approved the bill and added an emergency preamble (CAH-601).

SUMMARY: This is a new draft of LD 718 heldover from the First Regular Session of the 112th Legislature. The new draft provides for an increase in the minimum legal lobster size of 1/16th inch spread over a 3 year period. This action is made contingent on parallel action by the New England Fisheries Management Council enforceable throughout the U.S. through federal regulation or legislation. A national prohibition on the possession of v-notch lobster is also required. The increase is repealed on January 1, 1988 if these prerequisite actions have not occurred. The bill also establishes the framework for ongoing lobster management research. The bill is the result of a study by the Committee and its consultants entitled "Biological and Economic Analysis of the Lobster Fishery in Maine". A majority of the committee approved the bill. A minority of the committee felt that the measure was not justified and would impose unacceptable economic impacts of the industry. Floor amendments changed the measure increase to 1/8th inch over a 5 year period (HA-606), made a technical correction (HB-616) and corrected legal deficiencies in the effective date clause (HC-641).
