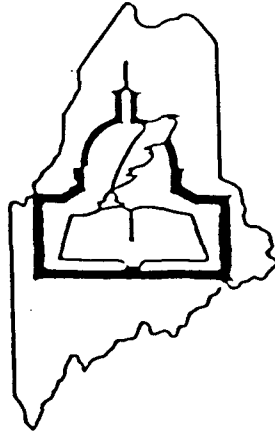

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

LD AN ACT TO CREATE THE AGRICULTURAL SUPPLIERS  
2331 INSURANCE PROGRAM

Sponsor: AYER, Violette, Lord, Gwadosky  
Committee Report: LVWD

SUMMARY: This bill proposed to establish a program for providing credit insurance up to an aggregate of \$5,000,000 to agricultural suppliers who extend credit to farmers who have demonstrated an ability to repay the credit. The Finance Authority of Maine would administer the program and would qualify suppliers for participation.

The bill also proposed to establish an Agricultural Suppliers Insurance Fund under the control of the Finance Authority of Maine and provide an appropriation of \$1,000,000 to the fund to secure payment of the authority's obligations under the program. In addition, it raised the maximum amount of bonds of the State that may be outstanding pertaining to insurance of eligible enterprises from \$77,500,000 to \$82,500,000. The State would guarantee 60% of the loan provided by suppliers to farmers.
