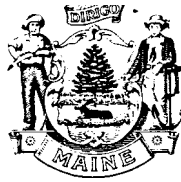

This document is a compilation of the bill summaries prepared by this office for the Joint Standing Committees and Joint Select Committees of the Maine Legislature, covering the Second Special Session and the Third Special Session of the 112th Legislature. The summaries are arranged by LD number under each committee.

All Amendments are listed, by paper number (e.g., H-584 or S-222), together with the sponsor if it is a floor amendment or the designation "CA" if it is a committee amendment. If the amendment was adopted in the House, the letter H appears after the sponsor. If it was adopted in the Senate, the letter S appears.

Final action for each bill is listed to the right of the title. If final House action and Senate action differ, both are listed.

SUMMARY: The new draft (the minority report) is identical to the majority report with the exception of the provisions establishing mandatory sentencing to the county jails.

This new draft would have deleted the county prisoner provisions; but would have established a full-time State position to provide technical assistance to the counties and a full-time State position to oversee community correctional programs.

SUMMARY: This bill authorized a bond issue in the amount of \$15,000,000 for construction and renovation of correctional facilities on a statewide basis.

The original bill allowed the Legislature to allocate these funds to any correctional facility within the State. House Amendment "F" (H-776) was adopted which specified the use of the bonds for building, repairs, or renovation of State correctional facilities. It also increased the bond issue from \$15,000,000 to \$16,000,000. Only one other amendment was adopted, H-777. That amendment added a fiscal note.
