SUMMARY: LD 14 proposed to increase the exemption from minimum wage laws for egg farms by exempting all farms with fewer than 1,000,000 hens, as opposed to the current exemption for farms with fewer than 300,000 hens.

SUMMARY: LD 64 proposed to increase the compensation of mediators under the Municipal Public Employees Labor Relations Act from \$75/day to \$125/day. The increase was to be phased in by increasing the compensation to \$100/day retroactively from January 1, 1987 and then to \$125/day beginning January 1, 1988.

The House Amendment (H-2) amended the bill by simply increasing the compensation to \$125/day beginning January 1, 1988 and added an appropriation section.

SUMMARY: LD 65 proposed to make investigative and employee rehabilitation records of the Workers' Compensation Commission confidential and not open to public review.

The Committee Amendment (H-7) made technical corrections to the bill and clarified that parties to a rehabilitation proceeding were not prevented from reviewing the records related to that proceeding.
