SUMMARY: This bill provides for consultant services for the Legislative Task Force on Railroads and extends the reporting deadline from January 1, 1987 to May 1, 1987.

24 BICENTENNIAL MOTOR VEHICLE LICENSE PLATE TO c. 3  
CELEBRATE THE BICENTENNIAL OF THE TOWN OF EMERGENCY

SUMMARY: This resolve permits the Town of Waterboro to issue a commemorative bicentennial motor vehicle license plate, to celebrate the town's bicentennial.

LD AN ACT RELATING TO INITIAL PLATES UNDER THE UNABLE TO  
43 MOTOR VEHICLE LAWS. AGREE

Committee Report: ONTP - OTP

SUMMARY: This bill would have permitted the issuance of registration plates with radio call letters to licensed amateur radio station operators, upon payment of a one-time service fee of \$5, and issuance of subsequent reregistration upon payment of a \$5 service fee.

LD AN ACT TO PROVIDE FOR AN ALTERNATIVE MOTOR ONTP  
47 VEHICLE LICENSE PLATE FOR CITIZENS OF MAINE WHO  
WISH TO HAVE AN UNDECORATED LICENSE PLATE.

Sponsor: MACBRIDE, Lisnik, Anderson, Cahill  
Committee Report: ONTP-OTP-A

SUMMARY: This bill would have allowed persons to obtain motor vehicle plates that did not display an illustration of a lobster.
