LD AN ACT TO INCREASE LOCAL CONTROL OF CERTAIN 139 WASTE WATER DISCHARGES. PL 1987 c. 318

Sponsor: MICHAUD, Holloway, Coles, Tuttle Committee Report: OTP-A Amendments Adopted: H-216 COMMITTEE

SUMMARY: The original bill allowed municipalities to exercise an option to assume the responsibility for licensing, inspecting and enforcing small (less than 2,500 gallons per day) waste water discharges currently regulated by the Department of Environmental Protection.

The committee amendment clarifies the original bill by (1) specifying general criteria which the municipality must satisfy before authority is delegated, (2) providing for an appeal from a municipality's decision on a discharge license, (3) requiring municipal ordinances to be at least as stringent as state and federal law, and (4) providing for adoption of rules by the board, including a model ordinance for municipalities.

LD AN ACT TO AMEND CERTAIN LAWS RELATING TO THE ND LD 1654 151 DEPARTMENT OF ENVIRONMENTAL PROTECTION.

LDAN ACT TO EXPEDITE THE PROCESSING OFPL 1987167ENVIRONMENTAL PERMITS.c. 274

Sponsor: USHER Committee Report: OTP-A Amendments Adopted: S-87 COMMITTEE

SUMMARY: The original bill sought to broaden the authority of the Commissioner of Environmental Protection to handle certain kinds of applications including expansions of existing structures under the Site Location Act, large air pollution sources under certain conditions, and all inland wetland permits. The bill also sought to explicitly deny the board the authority to review such "delegated" decisions made by the commissioner.

The committee amendment retained only those provisions related to expansion of existing structures and air pollution sources, striking all other provisions from the . bill. The provision concerning the expansion of existing structures was amended to limit the commissioner's authority only to expansions of structures located at facilities which had previously been approved under the Site Location Act.

AN ACT ESTABLISHING THE SONGO LOCKS ADVISORY LVWD LD 174 COUNCIL.

Sponsor: SIMPSON, Carroll, Black Committee Report: LVWD

SUMMARY: The bill provided a formal mechanism for the public to make recommendations to the Director of the Bureau of Parks and Recreation regarding the operation of the Songo Locks on the Songo River. The committee took the position that the existing informal consultations with local interests were sufficient.

AN ACT RELATING TO LANDS WITHIN INDIAN LD LVWD 178 TERRITORY.

Sponsor: CASHMAN, Carroll Committee Report: LVWD

SUMMARY: The bill would have exempted all Indian territories from the jurisdiction of the Maine Land Use Regulation Commission. Currently, only the Indian reservations are exempt.
