AN ACT TO AMEND THE MAINE TORT CLAIMS ACT TO

SUMMARY: The bill seeks to limit the liability of governmental entities and governmental employees sued under the Maine Tort Claims Act to damage awards not exceeding the extent of an entity's or employee's actual negligence.

AN ACT TO EXPAND ADOPTION REGISTRY

LVWD

Sponsor: ANTHONY, Clark, M., Brannigan
Committee Report: LVWD

SUMMARY: This bill sought to add to the types of people who can register for the adoption registry maintained by the Office of Vital Records in the Department of Human Services. Currently, only adult adopted persons, adoptive parents on behalf of minor adoptees, and biological parents may register for a possible reunion. Those who would have been included by passage of this bill were people whose adoption was annulled, adoptive parents of adopted persons who are deceased, relatives of deceased biological parents, adult siblings of adoptees, and custodians or guardians of minor or incapacitated adult adoptees.

SUMMARY: This bill sought to resolve a conflict between the Maine Tort Claims Act and a section of Title 30 establishing municipal liability for certain accidents involving a municipal fire department or volunteer fire association vehicle. LD 1777 incorporated the provisions of this bill.
